Natasha Moiseyev grew up in Palo Alto and has a solo business, Whole Family Solutions, that integrates law, mediation, advocacy and personal assistance for seniors and their adult children. As the mother of two children with congenital Lyme and a husband with latestage neurological Lyme disease, she is passionate about Lyme education and advocacy.

Lyme disease is widely misunderstood as an arthritic disease that emerged in Connecticut in the 1970s and has since ceased to be much of an issue on the national health front. Natasha will give a brief background on Lyme disease, common misconceptions concerning this sophisticated germ, the political intrigue surrounding the disease, and the current state of diagnosis and treatment of Lyme -- particularly as it relates to and overlaps with many symptoms experienced by seniors. She will be available to answer questions from her own research and experience, and will offer information sheets to interested audience members."

Half Moon Bay/Pillar Point: We will ride the paved flat trail along the ocean shore for about 6.5 miles from Poplar beach, located south of Half Moon Bay, to Pillar Point, just past the town of Princeton. We will return to Princeton where we will have lunch, then ride the same trail back for a total of about 13 miles. This replaces the Shoreline Park ride previously scheduled for this date.

New Ride Directions:

Take I-280 north (approximately 15 miles) to highway 92, then take the exit to Half Moon Bay. Continue on highway 92 about 10 miles to the

intersection with Highway 1, turn left. Go about one mile to Poplar St., turn right. Go to the end of Poplar St and park in the Poplar Beach parking lot, near the port-a-johns. Driving time is about 45 minutes. It may be windy and cold so be sure to bring a wind breaker and gloves to wear. Or, it may be a lovely sunny day.
