He is a journalist by trade and a publisher by profession, having published educational materials in the United States for over forty years, in print and on the internet. He was the founder and CEO of CyberGnostics, an online educational publisher. He is a committed naturalized American, speaks seven languages, and has traveled extensively throughout his life, at this point to over seventy countries. He has authored Resilient America – An immigrant examines our nation's adaptive continuity and lives in Menlo Park, in Northern California.

# Minutes of the Meeting of the Executive Board

**September 22, 2010** 

There being a quorum, Big SIR, Howard Trudeau, convened the meeting at 10:03 AM, at the Mountain View Shoreline Golf Course Pro Shop conference room.

The minutes of the August 25, 2010, meeting were approved without change.

It was noted by Big SIR that Senior Life Member, Al Gardner, was in attendance.

The following reports were submitted:

BIG SIR-Howard Trudeau:

Due to ill health Art Schmid will be unable to assume the duties as Secretary until January, 2011. In his absence Asst. Secretary, Wayne Richter, and Fred Van Kirk will serve as Acting Secretaries.

Big SIR will be unable to attend The October BEC and luncheon meetings. In his absence, Little SIR, John Geibel will conduct both meetings.

Big SIR announced that he and our 2011 Little SIR Al Stratz will attend the State SIR Leaders' Training Event in Vallejo on October 19.

Big SIR called attention to the "Activities Section" of the State website, SIRINC.org for an update of Branch activities which all SIR members are welcome to attend.

TREASURER-Don Harryman: The Branch 5 cash balance as of August 31, was \$6,115.62. The cash balance at the start of 2010 was \$6,111.76.

tions are welcomed and should be passed on to Big SIR.

Our current mailing list indicates we are sending out 128 Newsletters per month, 89 by email and 39 by "snail" mail.

At the August BEC meeting Big SIR requested Al to form a committee to explore ways to increase our membership. A committee was appointed consisting of Dan Haley, Les Spring, Duane Stauffer, Fred Van Kirk and Al. Al presented the following suggestions: make posters that would be displayed at places where seniors gather giving basic information about SIR Branch 5; post notice of our meetings and speakers in local weekly newspapers, e.g. Los Altos Town Crier, etc; provide each member with business size cards that could be given to prospective members containing information regarding meeting place, time, date, etc. Sample cards were made available to the members at the September meeting. Any comments or suggestions will be appreciated.

Our total attendance at the August meeting was 46 members and one guest.
