Actions prohibited by this rule shall include: "Solicitation of business or solicitation for volunteers, collection or distribution of funds, materials or other assistance by any person or persons at any luncheon or other meeting of the Branch." ### <u>SPEAKER</u>

Duncan MacVicar Biography
Duncan has degrees from the U.S.
Military Academy at West Point and
from UC Berkeley. He served in Viet-

nam as a captain in the Army Engineers. Later, he worked at the Lawrence Livermore Laboratory, Hewlett-Packard, and Spectra-Physics. He found his stride as a management consultant, advising high-tech company presidents on strategy, a career from which he retired two years ago. Along the way, Duncan was a founder of three high-tech companies, serving as CEO of one of them. He wrote a book on entrepreneurship entitled Managing High-tech Start-ups.

Duncan is a long-time community volunteer for his church and numerous nonprofits. He founded a group to build housing for the homeless, and last year he served as president of the board of Community Services Agency in Mountain View.

Today, Duncan devotes his time to the cause of veterans suffering from combat-induced trauma.

#### Visible Wounds of War

Duncan will describe for us the trauma that affects many combat veterans and the problems that these troubled veterans cause for themselves, their families, and their community when they return home. His points are illustrated by the stories of two local veterans of the current era. He will describe California's approach to traumatized veterans who commit crime and his efforts to improve that approach through legislation and the formation of special Veterans Treatment Courts.

# Minutes of the Meeting of the Executive Board

#### February 23, 2011

- 1. The meeting was called to order at 10:00 a.m.
- 2. A quorum was present. Those attending were: Howard Trudeau-Big SIR, Wayne Richter, Ray Odell-Attendance and Budget, Ken Liddicoat, Fred Van Kirk, Albert Stratz-Little SIR, Paul Butler-Membership, Don Harryman-Treasurer, Dan Haley, Zeke Sicotte-Auditor, Kamel Totah-Golf, and Art Schmid-Secretary.

There were no guests or visitors.

- 3. There were no corrections or additions to the minutes of the last meeting.
- 4. Big SIR report- Howard Trudeau:
- a. The newly printed membership roster for 2011 was distributed, which lists active members only. All meeting dates for year 2011 are listed.
- b. Inactive members- Rules regarding inactive members were discussed and are formalized in Article 7, a copy of which is attached. An inactive member will be requested to make a contribution of \$10.00 per year for the Branch bulletin. There was a discussion of the status of 10 inactive members, two of whom are former Big SIRs. Membership Chairman Paul Butler, along with Wayne Richter, will contact them and report at the next meeting.
- c. The February 1, Form 27 Monthly Membership Report was submitted and a copy is attached. This shows a total membership of 95, and January luncheon attendance of 47 members and one guest plus the speaker. As a side note, we were told that in the year 2000, our membership was 292 and lunch attendance was 169.
- d. The Holiday party will be December 14.

The Big SIR was informed by a member about the El Camino Hospital Road Runners organization and asked that the need for volunteers be mentioned at the Branch meeting. The Board agreed that although our group can be informed about this organization, in accordance with SIR policy, Branch 5 cannot sponsor the soliciting of volunteers for Road Runners or other similar organizations.

5. Auditors Report. S.D. Sicotte gave the auditors report for our Branch for year 2010,. He found the records main-

tained by our Treasurer to be in excellent order with supporting documentation.

6. The Treasurers report was given by Don Harryman and a copy is attached. For January 2011, our beginning cash balance was \$5406.92, and the ending balance was \$6112.88. Of our 95 members, we have only 41 who have paid their annual dues.

#### 7. Little SIR Reports:

Al Stratz reported that the number of people calling members to remind them about meetings has been reduced from 10 to 9 people.

Al and Les Spring visited Michael's to review the sound system They discussed our microphone and P.A. system and whether we should consider owning our own. The microphone provided is very directional, so our speakers should be advised to speak directly into it. The restaurant agrees to provide a microphone stand to aid in keeping the microphone in front of the speaker.

- 8. Membership Report-Paul Butler gave this report and a copy is attached. We have 95 active and 10 inactive members. Will Dettmer, badge 330, has resigned because of age. Visitor Michael Miller has no plans to join.
- 9. Attendance Report-Ray Odell. Attendance on January 26 was 49 members and 2 visitors. The full report is attached which includes a list of currently unpaid members.
- 10. Budget Report-Ray Odell. Detailed lists are attached showing expenditures for the year 2010, and year 2011 to date. It also shows a proposed budget for 2011 expenditures.
- 11. Our guest speaker today is Vickie Epstein who will speak about Avenidas Village.
- 12. There being no other business, the meeting was adjourned at 11:15 a.m.

Countless organizations around the world are racing against time to digitally preserve their collections of historical records before the media they are on turns to dust or jelly.

With the rising popularity of digging for our family roots, many of these organizations have discovered the benefit of posting searchable indexes of their records, and even the images of their records, on the Internet.

Richard Rands is a professional genealogist with over 50 years of experience working on his own family history and helping others trace their ancestors. A graduate of UC Berkeley with a BS in Operations Research and an MBA, he has worked for Hewlett-Packard Co., Tandem Computers, and the Tech Museum. He has recently retired as CEO of Computers for Marketing Corporation in San Francisco. Richard is currently President of the Silicon Valley Computer Genealogy Group, Director of the Los Altos Family History Center and proprietor of Brute Force Genealogy.
