# Minutes of the Meeting of the Executive Board

SIR BRANCH 5 EXECUTIVE COMMITTEE MEETING SEPTEMBER 28, 2011

1.The meeting was called to order at 10:11a.m. A quorum of 7 was present.

Those attending were: Al Stratz-Little SIR, Ken Liddicoat-Director, Fred Van Kirk-Director, Wayne Richter-Assistant Secretary, Ray Odell-Attendance, Don Harryman-Treasurer, Paul Butler-Membership, and Art Schmid-Secretary.

- 2. The minutes of the last meeting were approved as presented.
- 3. BIG SIR-Howard Trudeau: The Big SIR report was presented in absentia. This report shows a membership of 78 active and one inactive. The full report is on file.
- 4. Little SIR-AI Stratz. Our next meeting will be held on October 19, one week earlier this month. We have 78 active members in our Branch. By comparison, Branch 35 which meets in Mountain View, has about 400 members. We don't seem to attract younger members.

Our Computer group is attended by about 30 people. The group, which meets at the Elks Club, is said to be getting a bit technical for some members.

State SIR has available golf caps for sale at about \$10 each in quantities of 10, and Ball Point Pens at about 60 cents each in quantities of 70. Both items include a logo.

About 8 people typically attend our golf group, Greater attendance

would be beneficial.

5. Attendance & Budget Report-Ray Odell. Forty one members and two visitors attended our last meeting. This represents 52% of our current membership.

Financially we are doing well, with good cash on hand. However, there are 17 people who attend and haven't paid their dues. Al Stratz will call all those who fall into this category.

- 6. Monthly Cash Report-Don Harryman: The initial cash balance was \$5294.73 and the ending cash balance was \$5002.95. The full detailed report is on file.
- 7. Membership Report-Paul Butler: Seven inactive members were purged from our membership list. Three others have resigned. We have no new members. Our current membership is 78 Active and one Inactive. Our current Mailing List consists of 83 by e-mail, and 18 by conventional mail. Eight widows are included on the mailing list and these will be called by Paul Butler re their continued interest in the monthly mailing.

A Birthday List has been sent out. 8. Speaker Substitution-Our scheduled speaker was to discuss the USGS organization. She was unable to attend for some reason, but Al Stratz was able to get Martha Kendall who has written more than a dozen books, including one on the ERIE CANAL, which is the subject of her talk. Since the writing of these minutes follows the noon speaker's presentation, this secretary can report that the speaker did an excellent job. Both she and AI Stratz deserve our thanks for both her presence and an excellent job. 9. Old Business: Fred Van Kirk noted that we still need to find two more candidates to serve as Branch directors. For now, Fred knows of one possible candidate.

10. New Business: None.

meeting was adjourned at 11:05 a.m.
