# Minutes of the Meeting of the Executive Board

SIR BRANCH 5 February 22, 2012

 The meeting was called to order at 10:08 a.m. A quorum was present.
Those attending were: Paul Butler-Membership, Ed Schwabecher-Program Chairman, Ken Liddicoat-Director, Art Kraemer-Assistant Treasurer, Albert Stratz-Big Sir, Fred Van Kirk-Director, Duane Stauffer-Attendance, Don Harryman-Treasurer, and Arthur Schmid-Secretary.
The minutes of the last meeting

were approved as presented.

3. Auditors Report-Lloyd Lettis: A detailed auditors report was given and a copy is on file. Our Treasurer's records were found to be in good order. Our beginning cash balance on Jan 1-2011 was \$5406.92 and the ending balance on Dec 31 was \$3971.27. This shows a deficit for the year of \$1435.65. If not changed, our balance would be zero after three years. Some suggestions for reducing the annual deficit are given in the full report on file.

a. It was moved that we accept the Auditor's report. Seconded and Carried.

b. In lieu of our financial condition, it was moved that we just get a speaker and not have paid entertainment at our summer BBQ. Seconded and carried.

4. Monthly Cash Report- Don Harry-

**man**: Our Beginning Cash Balance was \$4131.27, and the Ending Cash Balance was \$4362.59. At this time, only 30 members have paid their annual dues. The detailed report is on file.

#### 5. Attendance Report-

**Duane Stauffer**: Attendance for the Jan. 25 meeting was 48 members, 4 guests and one speaker for a total of 53. Forty eight members make up 68.6% of our falling active membership of 70.

6. **Membership Report- Paul Butler**: There are no membership changes to report. We have 70 Active, one Inactive and 4 Widows on the mailing list. It was suggested that the four widows be contacted re their interest in remaining on the mailing list. The full report is on file. The FORM 27 Monthly Branch Membership Report submitted by Big SIR, Al Stratz, corroborates the above information , and includes data for each month as well as attendance data. A copy of this form is on file.

7. **Program Chair Report- Ed Schwabecher**: Ed presented an interesting chart which shows Branch 5 membership interest in 26 different activities ranging from Wine Tasting to Local Transportation projects.

Today's speakers are Charles Grant and Kristina Perino who will speak about the Rengstorff House. In March we are to hear about the Dementia Care Coaching Organization.

The full report is on file and lists other topics coming up in future months. 8. **Old Business**:

Ken Liddicoat recommended that we consider Les Spring as a candidate for the position of Honorary Life Member (HLM), and provided a nice resume of Les's numerous contributions over the years.

It was moved and seconded that Les Spring be awarded the position of Honorary Life Member. The motion was passed by a 100% vote of the members.

It should be noted that Ken Liddicoat has also been honored with this award some time ago. Thanks and congratulations hereby go to both of these Honorees!

9. New Business: The subject of Branch Officer and Directors Liability Insurance was discussed. Branch 5 has received a determination made by the SIR State Insurance Committee that the cost of obtaining such Liability Insurance exceeds 5% of the prior year's budget. Therefore it was moved that Branch 5 cannot afford to purchase this type of liability insurance, and the Branch elects to be covered by the provision of Section 5239. This motion was seconded and carried. 10. There being no further business, it was moved that the meeting be adiourned. The motion was seconded and carried.

The meeting was adjourned at 10:55a.m.
