# Minutes of the Meeting of the Executive Board

October 31, 2012

1. The meeting was called to order at 10:05 a.m.

Those in attendance were: Art Kramer-Assistant Treasurer, Ken Liddicoat-Director, Don Harryman- Treasurer, Al Stratz-Big SIR, Dan Haley-Greeter, Art Schmid-Secretary, Paul Krug-Forthcoming Secretary, and Pete LoPresto. Since only five of the above are officers, no quorum of six was present.

- **2.** The minutes of the last meeting were approved as presented.
- **3.** Big SIR-Al Stratz. We presently have 70 members in our branch, and desire a growth rate of 10% per year. Thus far we have four new members towards our goal, and expect one more to transfer in. The Form 27 Monthly Branch Membership Report was presented and is on file. It shows that typically 64% to 70% of our members attend the monthly meetings.

We should again encourage members to bring friends to lunch. In the past, we had a New Member Recruiting Committee plus business cards to distribute. Howard will talk to Les Spring and Paul Butler re the use of such cards in recruiting efforts, along with participation by Al Stratz. As an aside, it was noted that our youngest member is 66, which suggests that additional youth would improve our member diversity.

We need an information packet for new members, which could include a list of past speakers and the content of their talks. This would present an additional benefit of luncheon meeting attendance.

- **4.** Art Kraemer-Special Projects. A sympathy card was sent to the family of Jerry Levy who passed away recently.
- 5. It was noted that the proposed recommendations of Howard Trudeau regarding perfect attendance rules and perfect attendance recognition have been implemented after their adoption at our last meeting.
- **6.** Treasurer's Report-Don Harryman. For the month, the beginning cash balance was \$4049.15 and the ending cash balance was 3947.70. For the year, the beginning cash balance was \$4131.27 and the ending balance 3947.70. The full report is on file.
- 7. Our member Paul Krug has accepted the position of Secretary for the forthcoming year. Thank you and congratulations.

A Form 20 will be submitted to our Area Governor regarding the filling of this position. The current Secretary will also check on the SIR Rule regarding the holding of a meeting without

having a quorum.

**8.** There being no further business, it was moved that we adjourn. The motion was seconded and carried. The meeting was adjourned at 10: 41 a.m.
