Minutes of the Meeting of the Executive Board

SEPTEMBER 26, 2012

1. The meeting was called to order at 10:05 a.m.

A quorum was present. In attendance were the following: Paul Butler-Membership, Albert Stratz-Big Sir, Don Harryman-Treasurer, Ken Liddicoat-Director, Fred Van Kirk-Director, John Geibel-Assistant Secretary, Art Kraemer-Assistant Treasurer, Duane Stauffer-Attendance and Art Schmid-Secretary. Also in attendance were members Howard Trudeau and Pete LoPresto.

- 2. The minutes of the August meeting were approved as presented. The Secretary had nothing further to report.
- 3. Big SIR Report-Albert Stratz. The FORM 27 Monthly Branch Membership Report was presented which shows an Active Membership of 69, and a current membership goal of 71.

Our speaker today will be Andy Doty who was a tail gunner on a B29 in WW2. He has published a book titled, "Backwards into Battle." Al has a copy of the book, available for our reading.

A brief discussion was held regarding how we might improve our membership numbers. Howard Trudeau noted that we have taken in about 13 members over the last two years. It was thought that the use of membership cards might have benefited such growth. Paul Butler will ask at the Welcoming Table regarding card usage, and if such are needed, he can make them up on his computer.

At our luncheon meetings we should also encourage our attendees to ask their friends to visit to hear interesting speakers, and thus to consider joining.

4. Treasurers Report-Don Harryman. For the month, our beginning cash bal-

ance was \$4200.22, and the ending cash balance was \$4049.15. The complete report is on file.

Three members have not yet paid their dues.

5. Attendance Report-Duane Stauffer: Our typical attendance is 45 to 49 persons. Officers Stedman and Kranen attend periodically, plus our guest speakers, who are all included in attendance records.

Of our total membership of 70, an average of 46 attend the monthly meetings.

Some years ago, our membership was in the hundreds.

6. Membership-Paul Butler. We have 70 active and one inactive member. Our inactive member, who though inactive, likes to receive the bulletin.

The cost of mailing the bulletin will be evaluated around the end of the year in case procedural changes should be made.

- 7. Special Projects-Art Kraemer. No related mailings have been required recently.
- 8. Howard Trudeau has done the planning for the Holiday party which is to be held December 12. Entrees will be English Cut roast beef, Broiled Salmon, and Wild Mushroom Crepes.

Expected income is about \$250, while expenses are to be \$120 for entertainment and \$150 total for 10 prizes, for a net cost of \$20.

It was moved that the holiday budget be approved. The motion was seconded and carried. The full proposal is on file.

9. Howard Trudeau has presented two proposed regulations, one relating to perfect attendance rules, the other related to Perfect Attendance recognition. These proposals are significant in their content and include the potential establishment of the Al Gardner award to the member with the greatest number of years of perfect attendance.

It was moved seconded and carried that these proposals be adopted. Both proposals are on file.

It should be noted that these proposals though well thought out and well written, will still require very minor modification prior to their implementation. It is thought that this will occur via final discussion at our next

meeting.

Our thanks go to Howard, who has obviously been a busy man.

10. Prior to the close of our meeting, Al Stratz reiterated that the speaker today will be Andrew Doty who was a B29 tail Gunner during WW2. Further details about the speaker and his book are part of the Big SIR report given above.

11. The approximate cost of mailing the bulletin was discussed. Those not needing a mailed copy, should make it known in order to reduce our mailing costs.

There being no further business, it was moved we adjourn. The motion was seconded and carried.

The meeting was adjourned at 11:12 a.m.

Continue another 1/2 mile over several speed bumps to the park office and museum where you can park.
