At the intersection, turn Left on Lafayette and then immediately get into the right turn lane. The next traffic light intersection is "Gold St. Connector". Turn right. Go about ½ mile to another traffic light. This is Gold Street. Turn left, and go about ¼ mile. When you see a yellow traffic sign that warns of a "Narrow Bridge Ahead" prepare to turn right into the new Alviso Educational Center parking lot. Park there.
