# SUMMARY OF BRANCH 5 Executive Board MINUTES

- 1. Gary Hornberger called the meeting to order at 10:05 AM. There were five members in attendance: Gary Hornberger, Pete LoPresto, Roy Dreisbach, Chris Vasquez and Paul Butler. We did not have a quorum. (Mid-way through the meeting the following members joined, Dan Haley, Greg Kemist, Al Stratz, and Tom Donahue, which constituted a quorum.)
- 2. Additions or correction to minutes of September 28, 2016 BEC meeting and approval: There were no additions or corrections to the minutes and the minutes were approved.
- 3. **Introduction of Visitors and Guests** There were no visitors or guests
- 5. Big SIR reports:
- a. Chris Vasquez to be Acting Secretary with Paul Krug's resignation Chris Vasquez confirmed he would be acting secretary with Paul Krug's resignation

Officer Training date TBD - Gary Hornberger stated that officer training would normally done by the region and area governors but because both were out for various reasons he stated that the training is "up in the air". Pete also stated that the balance is \$1335.93. He stated that free lunch given to guests has accounted for the majority of the losses. Pete stated that he estimated Holliday expenses would be around \$1000 with \$500 going for Christmas gifts. Gary interjected that he has a budget that he will go over later in the meeting.

#### 8. Committee Reports:

<u>Attendance</u> – Tom Donahue - stated that the numbers were 34 attending with 2 guests and 1 speaker at the last meeting.

<u>Bulletin</u> – Les Spring - Les Spring was not present to report on the bulletin.

Membership (see attached) - Paul Butler - Paul Butler stated that there are no new members, no one resigned, one applicant and no one was deceased during the last period. He stated there are 61 members and one inactive member. He stated that eight members are receiving bulletins via US mail and he has received no corrections to names and addresses. During the Form 27 review, Gary stated that there was a 61 headcount and that of the 11 guests that 6 have become members with the conversion rate of 65%. All agreed that was good
