## MINUTES Executive Committee Meeting Minutes For August 23, 2017–

The meeting was called to order at 10:02 AM

A quorum was confirmed. The meeting attendees were Chris Vasquez, Carl Orta, Dan Haley, Pete LoPresto, Albert Stratz, Bob Simons, Paul Butler, Foster Kinney, Roy Dreisbach, Gary Hornberger, Tom Donahue

There were no additions or corrections to the minutes of June 28, 2017 and the minutes were approved.

There were no visitors or guests. Big sir reports:

a.Foster reported that the state is trying to order license plate holders and a sample is forthcoming by September 15th. He asked if there was interest. The board did not express interest. Foster said when the sample arrives he will raise the issue again.

b.Foster inquired of the board if we should order SIR hats. Foster proposed ordering a set of 10. Foster stated he would check into this.

c. Foster reported that area 13 has nine mid-peninsula branches and needs an area governor to start in January. Election to be held this coming Friday. He asked for interest. There was no expressed interest. Foster said he would report in September who this will be.

d.Foster gave kudos to everyone for a fine July barbecue.

e.Foster reported Jerry Ely starts today as the money collector. Chuck Cali will be assisting and appears to be the most experienced. Pete LoPresto volunteered to step out towards the end of the board meeting to assist. Pete will help determine who will be the chief revenuer.

6.Secretary's report - Chris Vasquez, The secretary had nothing to report.

7.Treasurers report and approval - Pete LoPresto

Pete reported \$1290 in income with 43 paid lunches. He reported \$1367 in expenses for a loss of \$77. Pete reported that the barbecue revenue was 1290 dollars and the expenses were \$1272.50 for a profit of \$17.50. Pete has been working with Chase bank. He stated that two people are currently on the account, himself and Al Stratz. He mentioned that Art Kramer is still on the list. Pete stated that he is working on getting Carl Orta as a signatory on the account. He is in need possibly of the articles of incorporation and Foster stated that he has the charter if needed. The SIR branch five executive committee approves the appointment of Carl Orta as Assistant Treasurer. The committee further authorizes Carl Orta to be added to the SIR Southern Peninsula Branch account at Chase Bank in order to conduct financial transactions of the Branch.

Pete stated there is a possibility of a couple of members possibly leaving. One of the members Ed Soohoo is ill. Greg Kemist will be asked to send a "Thinking of you" card to Ed.

8.Committee reports:

a. Attendance - Tom Donahue Tom was not in attendance at the time

b. Bulletin - Les Spring, Les was not in attendance

Membership - Paul Butler. Paul reported that there have been no new members and no resignations and we have been consistent at 60 members for three months. He reported that there are two possibilities for new members with two applications out for Rich Garcia and Bill Quackenbush. He also reported that 56 members could be reached via email. Paul said that he would remind the membership that if they have any changes to emails, phone numbers or addresses to contact him.

It was suggested that this notice be put in the newsletter. It was reported one member has not paid their dues and Foster suggested that this person be dropped from the list when the new roster is published.

Golf - Howard Trudeau, Gary re-

ported for Howard, that golf is doing very well. He stated that Howard is a great organizer and emails out the tee times and they have an average of 10 people playing every time. He also stated that three new members have been referred through the golf program.

Recruiting/retention - Bob Simons will report in September.

New member orientation - Phil Yurtis. Phil was not in attendance.

Speakers - Al Stratz, Al reported that we are expecting an interesting speaker today to talk about human trafficking. Her name is Lynette Parker and she is the supervising attorney at the Santa Clara law school in charge of this area. He stated that next month the speaker would be Denise Gluhan on who is a fire captain for Santa Clara County who will speak on the protection of seniors and their possessions during an emergency. Al reported that he is working on the October speaker.

Webmaster – Ed Nazzal. Ed was not in attendance.

Activities - Carl reported that bocce ball is going well with an average of 3 to 6 people playing. He publishes this information in the newsletter. Gary suggested announcing this at the meeting. Gary also suggested that Les Spring could send a "blast" out via his email list for the newsletter. Foster reported that Card's would be played today if members were interested.

9.Old business:

a. Review and recap July barbecue - Roy Dreisbach and Bob Simons. Bob passed out a summary of the summer barbecue signed up. He reported that 26 members attended and that it was well done. He stated that the members paid in advance and he also volunteered to do the December party. Board members comments included great job and Foster wanted to make sure that the minutes reflected appreciation for Bob and all those who helped for their hard work. ## Mountain View to Alviso

The Ride: We begin the ride at the La Avenida Trial Head and follow the Stevens Creek Trail for 1.5 miles where we connect with the Bay Trail. We continue the ride 3.5miles on the levees and old service roads as we cross the waters north of Moffett Field. (*Note: This portion of the Bay Trail has been resurfaced and is not bumpy as before*) We then head for Sunnyvale Baylands Park where we do go on packed gravel to downtown Alviso, where we will have lunch at a restaurant. The ride is 9.5 miles one way. We will return on the same route for a roundtrip of 19 miles. There are no optional shortcuts.

**Directions:** Meet at the La Avenida Trail Head at end of La Avenida Ave. From the intersection of Hwy 101 and Shoreline Blvd,head north on Shoreline Blvd. toward the Computer Museum. La Avenida is the first street on the right, but you can't turn there as it is a one-way street. Instead go past the Computer Museum to Pear Ave; turn right. Ingo Way is the next street; turn right. La Avenida is the next St.; turn left. (It is a two-way street here). Go four blocks to the end of the street. Park on the street, next to the curb.
