<u>Summary of Branch 5 Executive March</u> <u>Board Minutes</u>

MARCH 27, 2019-10:00 AM

- 1. Meeting called to order at 10:05 a.m.
- **2.** A quorum of six Board members was confirmed. In attendance were Chris Vasquez, Roy Dreisbach, Pete LoPresto, Gary Hornberger, Paul Butler, Howard Trudeau, Carl Orta, Bob Simons, Al Stratz, Foster Kinney and Tom Donahue.
- 3. The minutes of February 27, BEC meeting were approved.
- 4. There were no Visitors or Guests.
- **5.** Big SIR reports
- **a.** Latest Michaels cost discussions Roy stated that the cost per meal at Michaels remained at \$23.50. It was determined that a menu for the July barbecue would be put together and Roy would get this to Tanya. Roy stated that last year's July barbecue cost to members was \$30 and the holiday party was \$35. Roy recalled that the barbecue menu included chicken and tri-tip with sides. Roy said that hopefully Michael's would hold to the \$23.50 cost.
- **b.** Email list of members requested by Ed Benson Ed Benson, district director had requested an email list of members. It was determined that Paul Butler would send the list to Ed this year.
- **c**. Foster stated that he would be available to do an audit as discussed during the last meeting. After discussion the board decided that we would table this and not do an audit at this time.
- **6**. Secretary's Report Chris Vasquez had no items to report.
- 7. Treasurer's Report and approval Pete LoPresto Pete stated that he's been looking at members who have not paid their dues and has determined that four members should be dropped after past communications with them. The names of the four members (that are designated on the attachment by a "X" within a circle) will be dropped. He stated that he has sent three email letters to those members and has received no response. He said there was another member with the same designation on the sheet, with two "XX" that he needed input on. There was also a

discussion about the status of seven unpaid dues members and good input was given and status was determined for some of these members. The member with the XX designation who has not paid was discussed and it was decided that we would make this determination by the next meeting. It was also determined that it was important to be consistent and treat all members equitably when making these determinations.

Pete went on to give the treasurers' report. He stated we had an income of \$1071, \$390 of which was dues. Expenses were \$907.50 with a year to date gain of \$514.94. (Report attached) Pete also passed out a SIR branch 5-membership history sheet, which showed membership from the early 1990s to the present. (Attached)

He also mentioned that he had examined a list of the branches within SIR and found that there are 10 branches with under 50 members with the lowest being 31 members. He found the highest membership to be 340 members.

8. Committee Reports

Attendance – Tom Donahue stated that at the last meeting, there were:

Membership - Paul Butler passed out the membership report (Attached). He said that his numbers did reconcile with Pete for a total of 50 members after two had been removed that Pete had said would be dropped. Paul also stated that emails go out to 48 members and the report includes a corrected email address.

Recruiting/Retention – Bob Simons had no items to report. **New Member Orientation** - Gary reported that new member orientation occurs about every six months and reiterated that we need new members.

Speakers – Roy Dreisbach – Roy stated that Ed Mitchell would speak today about national missile defense. He said that Ed had previously worked at the Rand Corporation and Lockheed. He stated that he has speakers for April, May, June, July and October and also stated that there is a need for a speaker chair. He stated that there is also need for a member contact chair and that Foster is serving in this position temporarily.

Web Master – no report

Carl reported that holiday pictures had been uploaded to the website and also it was mentioned that it would be nice to provide the names for the officer picture. Carl said that he would address this. Carl also stated that he sent a picture of the bocce ball group to Les Spring.

<u>Activities</u> - Carl Orta – Bocce - Carl said that because of rain there has not been an opportunity to determine a date for a match with branch 35 but that date will be forthcoming.

Howard Trudeau - Golf - Howard stated that because of the rain there have been cancellations of the golf group and that they would probably not play tomorrow. He said that April signups would be occurring. He also stated that the golf lunch is scheduled for Tuesday, April 16th and that he is working with Tanya to arrange this. He said that their menu would be the same as last year including beef and salmon.

9. New Business:

Roy stated that there would be a short meeting regarding the upcoming barbecue after the luncheon meeting today. He is considering a \$30 charge for this luncheon. Gary offered to collect funds as the date approaches for Bob Simons as Bob will be vacationing during this time.

It was reiterated that we will postpone any assessment of the membership and there was a discussion on the value of this.

Foster said that he recommended approaching retirement communities as one source of new membership. It was a good discussion on the value of advertising and becoming more known in the community. It was also agreed that per our practice of allowing caregivers to accompany members to luncheons that Fred Van Kirk's daughter would be authorized to accompany Fred to the luncheon today.

It was agreed that Gary would send out the remaining roster booklets to members who have not received them via snail mail. Gary offered to pay the postage.

Foster volunteered to call people who are not attending meetings and would like a copy of the list that Gary sends the rosters out to so he can follow up with them to determine why they are not attending.

Roy said that he would make announcements about the availability of playing cards today.

Foster passed around pictures of his recent trip to Rhode Island of maple syrup harvesting as well as samples of maple syrup candy.

11. Call for adjournment - the meeting was adjourned at 11:10 AM.
