Rides start at 11:00 a.m.. & include a lunch break at a restaurant. Thursday, February 14, at 11:00 AM. Wives and guests are welcome . Rain cancels: Helmet required. Coyote Creek Trail (South San Jose) Ride: We will ride the Coyote Creek Trail starting from the Wyndham Garden Hotel at 399 Silicon Valley Rd, San Jose. The ride will be about 6 miles to the Coyote Creek Golf Course. We will go past the golf course another 3 miles to a model airplane launching site, then double back to the golf course club house for lunch. Turn left on Rue Ferrari Rd., the service road next to the hotel, and park in the hotel parking lot behind the furthest hotel building on the right.
