What a fascinating life member Mark Bosch outlined for us during his presentation at our luncheon on Tuesday. Mark's cousin twice removed Allan Bonnalie built airplanes in his San Francisco garage in the early 1900's then went on to fly as a US Army officer in combat while gathering reconnaissance photos over the trenches of WWI. Allan later served as a Navy officer in WWII and after that war as an airline executive widely credited with making airlines one of the safest ways to travel. He had all those accomplishments plus he lived to be 90 years old, what a life! Our fellow Sirs member Mark Bosch sure has an illustrious family member with a proud place in history.

I would like to say how grateful I am for having the opportunity at our luncheon to lead our club in expressing our club's appreciation to our many military veterans for their place in history. SEPTEMBER 24, 2019 SPEAKER REVIEW

On September 24th fellow Branch 47 SIR member Attornev George Martinez shared with us some highlights of his sixty years practicing law. George graduated from USF Law in 1959, and after working with George T. Davis for four years opened his own law office with other attorneys in 1963. He has been busy ever since and became "inactive" (retired) "a year ago last January." I could fill this entire page with his impressive creds and bio, but I need to save some room for his presentation, so will stop with this: George has been awarded a rating of "AV Preeminent, the highest possible rating in both legal ability and ethical standards" by his peers "pursuant to the standards of Martindale-Hubbell." Just so we know, this distinction covers criminal defense, personal injury, and civil litigation

Now for the hard part. George's first really big case commenced in 1966 when he represented Don Silverthorne. President of San Francisco National Bank. Silverthorne was indicted on 79 counts of violating banking laws, misapplication of funds, making false entries in bank records, and various alleged violations of federal statutes. Approximately 56% of the bank's assets were either improperly used or loaned or placed beyond the chance of recovery. On January 22, 1965 the bank was ordered closed because of insolvency. Silverthorne was convicted of 14 counts, but the result was reversed on appeal, primarily because there was so much publicity in the Bay Area surrounding the trial. In 1969, Silverthorne got a new trial and was again represented by Attorney Martinez. In this trial, three counts were thrown out, but eight were upheld. He received a sentence of eight years but was released "after little more than a year" because of poor health. George spent five years on these cases, and as he remarked after his coverage of this case, he doesn't "know if justice was done." On this subject, I would like to hear more.

Next, George spoke about Patty Hearst and her case(s) and legal problems after her conviction for bank robbery in 1976. George made it clear that he did not represent Hearst in her bank robbery trial "and doesn't take credit for that case," but he did get involved after her trial and during her appeal in matters relating to conflicts of interest by her attorney F. Lee Bailey whose agent was in negotiation with a publisher for a book contract about Patty during her appeal. George petitioned the Supreme Court for a hearing arguing that Bailey's book contract was "a prohibited conflict of interest" and that her "conviction should be vacated based on new authority." This book issue was never settled, but it hasn't prevented the publication of numerous books and movies about Patricia. George has represented her in "ongoing matters

Hearst is a grandmother living, I presume, somewhere in California, involved in a foundation helping children with AIDS. Her memoir, *Every Secret Thing*, was published in 1981, and she has appeared in several feature films by John Waters. Finally, she has won top awards with her show dogs at Madison Square Garden in 2015 and 2017. George and his wife continue to be in touch with her.

Finally, George spoke about the Voting Rights Act which was signed into law by President Lyndon Johnson on August 6, 1965. We were all around at that time but may have forgotten some of the details, so George kindly brought them to our attention. In 1964 three civil rights workers /voting rights activists were murdered in Mississippi which resulted in numerous demonstrations and considerable violence. State troopers in Selma. Alabama attacked peaceful marchers who were protesting the suppression of voting rights for blacks which were guaranteed by the Fifteenth Amendment. George went to Mississippi with George Moscone, Terry Francois, and Jim McDonald in January of 1965 in response to Mayor Willie Brown's request for volunteer attorneys to determine how Mississippi's voter registration laws were applied and to gather evidence of voter suppression through depositions which, they assumed, would expose the "devices" and policies (such as literacy tests, poll taxes, and other bureaucratic restrictions) that southern states used to deny blacks the right to vote. It was generally accepted that what these volunteer lawyers were doing was potentially dangerous, but obviously George survived his two weeks of deposition taking, and the result was a stunning victory for civil rights/voting rights activists. However, as George pointed out, some provisions of the Act have been challenged since its passage, notably the requirement that states with histories of black voter suppression must clear with the Justice Department any changes in their procedures for voting. The Supreme Court struck down this requirement in 2013, and the result has been "several gerrymandering cases where voting districts were claimed to be drawn on race," according to George. Clearly, this is a "developing" story which, despite the impact of The Voting Rights Act, seems to have legs. If you want more detail on this subject, there's always Google! But keep in mind: it's complicated.

Thank you, George, for sharing with us your memories of these three fascinating involvements. As we say at SIRS, "Cheers" and may you continue to enjoy your retirement.


