Time goes by so quickly now days; I feel like I just wrote something a few days ago. The weather has been a little questionable too, I missed the last two golf tournaments to rain and with Rolling Hills coming up soon I could have used the practice. One of the things that keeps coming up in our BEC meetings, is the cost of everything we do in the Branch. As Big Sir I get an opportunity to talk with other Big Sirs and State Leaders quite often. I have recently been asking them about their costs and what they charge for certain items. Luncheons are typically between \$25 and \$30, and the dues are most often \$40. We are currently charging \$20 for lunch and \$25 for dues. At the luncheon we pay for our Speakers lunch, and for any guests we bring in and we also buy wine for the raffle. And now that we have the Bar back, we are committed to paying the difference between what we spend and \$175. In addition to that I have just recently learned that the State Sir requires that we maintain our Bank Account at \$2400. We also have been supplementing the Picnic and the Christmas Party costs. What's even worse now is that the cost of everything; gas, food, drinks, wages, you name it, is going up! So, don't be surprised when we increase our costs to \$25 for lunch and \$40 for our dues. We have been paying around \$200 a year for our web site too. Fortunately, the State Sirs is providing our new web site for free. Which brings me to our web site situation. We will no longer have access to our current web site after this month. We have transferred a lot of the stuff (Technical Term) from the site to the new web site, but not all of it. As webmaster, I have decided that we need a fresh look at what we have been putting on the site. The Golf info, and the Newsletters are obviously needed, and they are available now. We will discuss what is truly needed on the site starting May 1st. The new site is located at: *sirinc2.org/branch102/*. We are planning on making that either Sir102.org or Sir102.com if we can. Next Luncheon is Tuesday, May 10, 2022; Cost \$22.00

Note: The Elks Club began charging the Branch \$22.00 per lunch in March 2022. The Branch continued to charge the membership \$20.00 for lunch and absorbed the increase for March and April. The Branch subsidy for these two months was approximately \$300. The member cost is now increased to \$22.00 and will remain the same for the months of May, June, and July. Even at this increased amount, the Branch absorbs the cost of no shows if the guaranteed minimum attendance for each luncheon is not met. The guaranteed minimum is based upon the number of members replying "Yes I will attend and eat" to the survey that goes out before each luncheon. If a member does not reply "Yes, I will attend and eat" and attends the luncheon and eats, the amount of food prepared may not be sufficient to accommodate all those that have paid for a lunch. The Branch also absorbs the costs of the speaker, guest member lunches, and the wine for raffle prizes.
