

MINUTES

SIR Branch 129 Executive Committee Meeting

October 3, 2024 – 9:30 A.M.

Regular Meeting Held at Redding Elks

<u>Call to Order:</u> The Regular Branch Executive Committee (BEC) Meeting was held at the Redding Elks and was called to order at 9:27 A.M. by President Lee Lamp. A quorum (requires 5 BEC members) was present. All Officers and all Directors were present except Cris Andrews and Gerry Dodge who were excused.

Members Dick Fyten, Jerry Sanchez (a new member), and Len Napoli were in attendance.

Welcome Guests and Visitors:

The President welcomed officers, directors, committee chairmen, regular members and guests.

Consent Agenda Approval (Lee Lamp):

President Lamp asked for a motion to approve the "Consent Agenda."

Motion made by Sid Nobles and seconded by Dennis Compomizzo to <u>accept the "Consent Agenda" as presented including approving the Minutes of September 5, 2024; the Secretary's Correspondence Report; and the Treasurer's Report (Form 28).</u> The motion passed unanimously.

Vice-President's Report (Morgan Akin):

VP Morgan Akin said that Darlene Brown currently on the Board of Directors as the Secretary and Past President with the "Shasta Lake Historical Society" will be the speaker at today's luncheon.

VP Akin said the November speaker is Norm Hall of Simpson College talking about their new football program.

President's Report (Lee Lamp):

Update on State SIR Issues:

President Lamp reported that he and President-elect for 2025, Barrie Lee, attended the State SIR Annual Conference in Lafayette on September 24th. All the 2025 Nominees for State SIR office were elected. Lee Lamp was elected State SIR Vice President for 2025.

Information from the Annual Meeting was discussed by President-elect Barrie Lee. A copy of the Agenda and "White Paper Clarifying SIR Inc. Issues" are attached to the Minutes.

Reimburse Barrie Lee for Cost to Attend Annual State SIR Meeting:

President Lamp's expenses were covered by the State SIR however Barrie Lee's expenses were not covered by the State. After some discussion about the importance of having Branch 129's President-elect attend the State meeting the following motion was made:

Motion made by Dennis Compomizzo and seconded by Rix Callaway to <u>authorize the Treasurer to reimburse President-elect Barrie Lee for costs associated with attending the Annual SIR State Meeting for 2024.</u> The motion passed unanimously.

Treasurer Callaway paid Barrie Lee by check to reimburse him \$184.31 for his expenses related to the Annual SIR State Meeting as approved by the BEC.

Update on Advertisements & Publicity for Branch 129:

President Lamp purchased some signage to be used at our luncheon meetings. The purpose is to identify our Branch 129 so that guests and new members know they are at the right place and to advertise our existence to those who may be at the Elks Lodge.

Jerry Sanchez reported on his afternoon at the Information Booth: More than 30 brochures were handed out and many more contacts were made at the Honey Bee Festival. He said that there are plans to be at the "Anderson Festival" on October 11th and at the "Christmas and Country Fair" on December 6th. In addition, there are plans to have a booth at the weekly Farmers Market at City Hall.

Update on Local Festivals & Events to Advertise Branch 129:

It was reported that Jim McMahon volunteered to set up a Pop-up tent, table and signage to promote Branch 129 at the "Honey Bee Festival" in Palo Cedro. He was there to hand out flyers and have applications. He had help from Jerry Sanchez.

Christmas Party Committee Report: (Dick Fyten)

At the September meeting Dick Fyten reported that we secured the Sons and Daughters of Italy facility for our annual Christmas Party and Installation of Officers and Directors for 2025. The date is December 11, 2024. Dinner will be the turkey, stuffing, mashed potatoes, gravy, yams, vegetables, salad, rolls, and dessert. The cost is \$25 per person (includes tax and gratuities) with a minimum of 75 guests guarantee. The bar set-up fee is \$100 for a no host bar. Coffee and water will be supplied. Dick presented a detailed spreadsheet showing the projected expenses and income for the party.

Pat Karch will play for a fee of \$150.

Dick will print up a menu for each table at an approximate cost of \$100.

Secretary Andrews printed the tickets at no cost and they are available for sale at the October and November meetings. Rix Callaway will manage the ticket sales starting at the October luncheon.

Motion made by Morgan Akin and seconded by Ken Timmerman to approve the member-ship applications as presented. The motion passed unanimously.

The three new members will pay no dues for 2024.
