# **SIR Branch 129 Executive Committee Meeting**

June 12, 2025 – 9:30 A.M.

# **Regular Meeting at Redding Elks Lodge**

<u>Call to Order:</u> The Regular Branch Executive Committee (BEC) Meeting held at the Redding Elks Lodge was called to order at 9:30 A.M. by President Barrie Lee. A quorum (requires 6 BEC members) was determined by Secretary Andrews. All Officers and all Directors were present except David Yorton, Sid Nobles who were excused. Also in attendance: Dick Fyten and Don Arnold. Len Napoli came in near the end of the meeting.

# Welcome Guests and Visitors:

President Barrie Lee welcomed officers, directors, committee chairmen and/or guests.

# **Consent Agenda Approval (Barrie Lee):**

President Lee asked for a motion to approve the "Consent Agenda."

Motion made by Gerry Dodge and seconded by Lee Lamp <u>to accept the "Consent Agenda" as presented including accepting the Minutes of May 1, 2025; the Secretary's Correspondence Report; and the Treasurer's Report (Form 28).</u> The motion passed unanimously.

#### Vice-President's Report (Morgan Akin):

Vice-President Akin reported the speaker for today is a spokesperson for Redding Area Bus Authority (RABA).

#### **President's Report (Barrie Lee):**

Appoint 5<sup>th</sup> Director to Fill 2025 Open Spot:

President Lee explained the history of having 5 Directors and dropping back to 4 Directors and then reinstating the original 5 Director positions. He reported that he wants to appoint Don Arnold to fill the 5<sup>th</sup> Director vacancy. Nominating Chairman Andrews said member Don Arnold agreed to volunteer for the position for 2026 and his name is now on the Slate of Officers and Directors for 2026 to be presented and voted on by the BEC. Without objection President Lee appointed Don Arnold to the 5<sup>th</sup> Director position and administered the oath of office. The BEC welcomed Don Arnold.

Announce July Meeting Dark:

President Lee reminded the BEC that because the July meeting falls on July 3<sup>rd</sup> Branch 129 will hold no BEC meeting or Luncheon in July. These changes will be announced to the membership and will be noted in the Newsletter.

Director and Facilities Chairman, Sid Nobles, will let Claudia and the Elks know that we won't be meeting in July (*Note: The Elks and Claudia may already have been notified that we aren't meeting in July*)

# **Old Business**

*Update on Publicity, Advertising, & Recruitment (Jim McMahon/Barrie Lee):* 

President Lee emphasized that Jim McMahon would continue leading the effort to participate in community events with the President's oversight. President Lee and Jim McMahon will look for venues that are appropriate for our branch, which are reasonably cost effective, and where we have enough volunteers to work a booth. In addition, President Lee said that SIR Branch 129's participation in appropriate venues would generally be limited to 3 hours (the exception would be if enough volunteers were available for a longer participation). President Lee said we have gotten off to a slow start this year because Jim McMahon has had some medical issue to deal with.

*Update on State SIR Issues (Lee Lamp):* 

Branch 129 Director and State SIR Vice-President Lee Lamp reported on State SIR issues. He said the State Board is reviewing the State Policy manual in order to revise it. Policy 20 has been rewritten to allow more latitude for branches to deal with non-member participants.

Lee Lamp announced he has resigned from the State SIR Vice-President position and won't be the State SIR President next year. He explained that he resigned for personal reasons but will remain active as a Director on Branch 129's BEC and will continue to chair the 18-Hole Golf Group and publish the Newsletter and maintain the branch database.

Lee also reported that the ID and password for the "members" area of the State SIR Website has been changed and the President (Big Sir) for each branch will determine who has access to the new ID and password. The old password is effective until the end of June. President Barrie Lee said he will make sure that any member wanting access to the member area will get the ID and Password. (More to come on how to make this known to our members.)

Report on Dues Paid to Date (Rix Callaway):

Treasurer Callaway reported that 98 members have paid their annual \$50 dues.

At the May 1<sup>st</sup> meeting President Lee suggested that we don't drop any unpaid members until the June 12<sup>th</sup> meeting.

Treasurer Callaway explained we dropped 3 members from the database and membership roster. President Barrie Lee thanked the Treasurer and said no further action was necessary.

#### **New Business:**

Consider Approving Slate of Officers & Directors for 2026 (Cris Andrews):

Nominating Chairman Andrews presented the Slate of Officers and Directors for 2026 for the approval on the BEC. He explained that once approved the Slate would be published in the July and August Newsletters and would be presented to the general members at the August 7<sup>th</sup> Luncheon for a vote of the members present. He explained that nominations can also be made from the floor for any position up for election. After some discussion, the following motion was made:

Motion made by Gerry Dodge and seconded by Rix Callaway to approve the 2026 Slate of Officers and Directors as presented by the Nominating Chairman, to be published in the Newsletter, and presented for election at the August 7<sup>th</sup> Luncheon. The motion passed unanimously.

President Lee thanked the Nominating Chair for putting the Slate together.

*New Member Certificate of Membership Process (Barrie Lee):* 

President Lee discussed the "Certificate of Membership" for new members crafted after the example on the State SIR website. Currently Phil Perry sends new members their badge number, a history of SIR, and the most current Newsletter.

President Lee said he would talk to Phil Perry concerning how best to get a "Certificate of Membership" to new members. The "Certificate of Membership" could be presented to the new member at the luncheon when the new member is introduced and asked to give a short bio or if the new member doesn't attend the first luncheon after becoming a member, the certificate could be included with the information that Phil Perry currently sends out to the new members. President Lee will report back on how the process will work.
