Branch 129 Historical Tidbits Submitted by Cris Andrews

From the January 2004 "SIR UPDATE"

This month I thought I would write about members who are second generation Branch 129 SIR members. I know of two, Dennis Compomizzo and Tim Holmquist. If there are more, please let me know.

Tim Holmquist's, a relatively new member of Branch 129, father was Harvey Holmquist who joined Branch 129 in the late 1980's and served as Big Sir in 1990 and 1991. Harvey retired from Shasta County as the Chief Building Inspector. My father, Robert Andrews, was also a Building Inspector for Shasta County and he and my mother were close friends with Harvey and Dorothy Holmquist. I finally met Tim at the January 2026 luncheon, and he confirmed that his dad was a former Big Sir. Harvey was a member until sometime in 2007. Interestingly (at least to me) I joined SIR in late 2007 and had to wait until there was an opening. It may be that I took Harvey Holmquist's place.

Dennis Compomizzo's, a member of Branch 129 and a Director on the BEC and the Bocce Chairman, father was Orlan Compomizzo better known as "Compy", was a member from 2002 to 2008 or 2009. In the January 2004 "SIR UPDATE", under the "Sunshine Report", there was an article about "Compy" Compomizzo. The article said "...Compy had a 5-way bypass a few years back, and as is usually necessary after five to ten years, returned to Mercy Hospital, after our last SIR meeting for a renewal, a 4-way. Because of some heart fibrillation, the doctors gave some treatment to restore a normal heartbeat." Dennis told me he didn't know that his father had been a member. His father passed away in October of 2016.

The Racing Report by Barrie Lee

As I've stated recently, my focus in this column is to inform my readers of the interesting stories about racing and not to keep track of each race, both in Nascar and IndyCar racing. I haven't had the time in the past to explain both series and give the history of both venues. By explaining their histories and focussing on details about the sport, I hope to better inform you why auto racing has reached the current levels of interest by sport fans.

Nascar has been around since the late 1940's. After WWII there was an interest by many to form a stock car racing format. It started in the southern states where moonshiners built up their vehicles with larger horsepower and lighter cars to be able to outrun the law. Junior Johnson was a prime example of this process. He was a moonshiner by trade and a very fast driver. However, he was eventually caught and served time in prison. He eventually became a farmer after his release from custody. His new venture was named "Holly Farms". I'm not sure where the name came from, but my guess is Holly was and is a carburetor manufacturer. He raced his own cars in the early years of Nascar and later hired Cale Yarborough to drive his Chevies. The Bill France family formed Nascar in the early 1950's, I believe, and they created a sanctioning body that still works today. I'll expand on this information over time, but one of my goals this year is to shorten the length of the columns.

IndyCar is a different story altogether. This series started in 1911 in Indianapolis, Indiana. In the early 1900's automobiles were being built all over the country. Several companies were located in and around Indiana. The main problem companies had back then was finding a place to test drive their products. So four owners of these companies bought four eighty acre parcels that joined each other in western Indianapolis. They came up with an oval track design that fit within those 160 acres giving them the best use of the land. They proceeded to build the track with millions of bricks that were supplied by a quarry north of Indianapolis. The track length was set at 2 1/2 miles. The new track allowed the companies to test their designs and it worked well for all four. However, the track sat much of the time without being used. I'm fairly sure they leased the track to other manufacturers, but it was still under utilized. So, by 1910 the four owners decided to form a yearly racing event to better use the facility. They built grandstands and other features that would let the crowds enjoy their experience at the track. They ran roadsters back then and had a mechanic aboard to help these early machines make through 500 miles. Mechanics were used until 1915 when they only had drivers on board. Eddy Rickenbauer was a mechanic until 1915 when he started driving. They didn't race in 1917 or 1918 because of WWI.
