1.0 Call to Order at 1:08 pm.

4.0 Approval of the Minutes

Following motion made by Bill R. and seconded by John C. it was

RESOLVED, that the minutes of the November 10, 2020 BEC Meeting are hereby approved as written.

5.0 Treasurer's Report

5.1 Treasurer's Report: Harry M. reported the ending balance was \$1,895. Harry noted that the balance decreased by \$78 due to the Newsletter expense. A motion was made by Mark W. and seconded by Bill R.

The motion passed unanimously.

6.0 Committee Reports

- **6.1 Membership Report:** Stephen H. reported that membership remains at 130 members. Stephen H. stated that he has received one application for membership. Approval of the application was deferred until the March meeting.
- <u>6.2 Golf Report</u>: Bill R. reported that he had distributed the following materials by email to all BEC members prior to the meeting.

All present approved the motion.

Bill R. stated that the Stockton Branch BEC approved the State Resolution, State Protocol and the Combined Schedule at their meeting on February 8, 2021. Discussion ensued.

Big Sir Paul W. proposed that, since a quorum was not present, the motion would be distributed to the Officers and Directors not present in order to secure additional approvals of the above motion.
