1.0 Call to Order at 1:23 pm.

We had two applications to consider for membership today. The first is from Jim Jacobsen, who is sponsored by Mike L. **A motion was made by Glenn N. and seconded by Joe S. to accept Jim Jacobsen's Application. The motion passed unanimously.** We also had an application from John Seahorn. He was sponsored by Juan O. **A motion was made to accept John's application by Glenn N. and seconded by Mike L. The motion passed unanimously.**

The motion passed unanimously.
- 8.3 Stockton Maritime Museum Support: Glenn asked that our chapter formally support the effort to make the Minesweeper Ship Museum in Stockton. After some discussion, a motion was made by Tony M. and seconded by Glenn N. to write a SIR letter in support of the Maritime Minesweeper Museum of Stockton. The motion passed unanimously.
