#### **Big Sir APRIL 2024 Remarks**

Gentlemen, I would like to thank Mark Walhman, John Coakley, and Joe Stephens for helping in the search for a new luncheon venue, and survey. I would like to thank all the members who participated in our survey. The results are as follows:

80 points for Casa Flores

72 points for Elkhorn CC

58 points for Lodi Bowl

The points awarded were 3 points for 1st choice, 2 for 2nd, and 1 point for 3rd choice.

Casa Flores got 19 first choice Elkhorn CC got 11 first choice Lodi Bowl got 5 first choice

The BEC will discuss the outcome, and a recommendation will follow.

I met with Liz, the banquet manager, we discussed the menu, and the cost. Liz, stated that the SIRS were getting a special price for the luncheon. She stated the cost of the banquet room is \$1600.00, for a one time used they charge a minimum of \$30.00 per plate per person in addition to the \$1600.00.

Our menu is very simple we have chicken prepared with special sauces, pork loin, and Lasagna. Also, served with red or mesh potatoes, salad, bread, coffee, and tea all for \$26.00. Breaking down the luncheon it would cost \$3.00 for coffee, \$3.00 for tea, we have both. The main entree cost \$18.00, add the salad, the potatoes, and bread for additional \$6.00. The cost would be \$30.00 and a 20% gratuity is \$6.00 for a total cost of \$36.00, we get it for \$26.00 a \$10.00 discount.
