1.0 Call to Order at $1: 14 \mathrm{pm}$.

4.0 Approval of the Minutes for March 8, 2024:

### 5.0 Treasurer's Report/Action

Joe reported a beginning balance of $\$ 2844.49$. The expense for the Newsletter was $\$ 118.26$, and printing tickets for the picnic was $\$ 35.26$, We had income from dues of $\$ 280.00$ and $\$ 39.00$ from the raffle. Leaving an ending balance of $\$ 2932.03$. This amounted to a a gain of $\$ 87.54$ for the month. The motion to accept the financial report was moved by Mike L. and seconded by Bill R. ### 6.0 Committee Reports
