If you have any questions or comments about our branch, please feel free to contact me or one of the members of the BEC and we will address them.

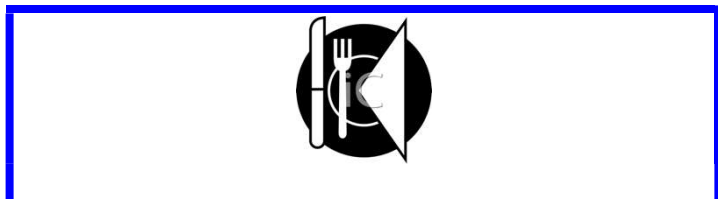
