Greetings and Happy Valentine's Day to you. I hope you will be taking your wife or significant other out for a nice dinner on this special occasion., or at least buy her a nice box (heart-shaped, of course) of chocolates.

For our first luncheon of the year, we had a fairly decent turn out with 81 members and 3 guests attending. As mentioned in our January SIR Bulletin, the State minimum goal for luncheon attendance is 70%. We are averaging less than 60%. Let's make a greater effort to attend our luncheons. We are non-profit, non-money making organization, so we depend solely on your membership dues and contributions. We do not want to lose your support or membership, but we need your cooperation and assistance regarding this urgent matter. For those who have paid their dues in a timely manner, I thank you for your courtesy and support.

On the lighter side, we have a new member in January. His name is **Dennis Milar**. You may have met Dennis last year when he was a luncheon guest of **Larry Shelley's**; he joined Larry in singing and playing his ukulele. Welcome Aboard, Dennis. We hope you will be active on some of our committees. We also welcomed 3 guests at our January luncheon: **Larry Harris, John Sincel, and Norm Barkley**. We would love for them to become members. Our growth depends on it.

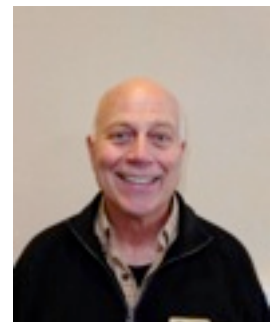

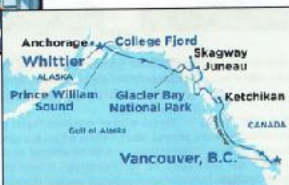

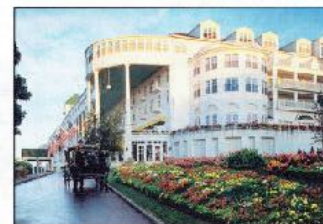
