Get Ready for the New Bocce Year! Due to winter closure of the DeLaveaga courts, we are using the Felt Street courts until further notice. The Felt Street park is near the Simpkins Swim Center off 17th avenue. Managers will be responsible for notifying players about possible Rain-Outs.

Note from Mike Kopp on the condition of the Felt St courts: "after 1.5" of rainfall in the last 24 hours, the Bocce courts were damp, but no standing water. Rolled a few balls on each court- they ran true. Only slight drawback is a few weeds sticking their heads up along the edges, but a couple minutes with a serrated blade will alleviate the issue. Ample parking off street- between the small lot and an unpaved lot next door, should be good (Posted no street parking on Felt in front of the park)."
