**September's Speaker,** SIR Forrest Holleman, "Ageing, What YOU Can Do to Remain Independent". Forrest is a key member of Global Eyes LLC and works with businesses and individual entrepreneurs on business development and change management.

SIR Email and Internet Security . Bill Gipe. Anthony Ramirez and your Editor attended the SIRInc Zoom presentation on Computer and Cell Phone Security on August 16<sup>th</sup> along with over 200 other SIRs. This 90-minute presentation included questions and answers and was moderated by SIR Alan Baker. Alan also works with AARP to design and share internet and smartphone threats and precautions. The information below was distilled from the very thorough presentations and Q and A's.

I want to concentrate on specific schemes actually experienced by SIRs rather than defining categories. AARP does a very good job of defining. Go to their Website for a thorough glossary:

Specific examples discussed include:

- 1. A message supposedly from someone you know asking for some sort of help (cutting a check, buying gift cards, etc.
- 2. A similar message asking you to respond to let them know you are available to talk.
- 3. A call from "Microsoft" saying your computer has a problem they can fix it if you give them information.
- 4. A message with an "invoice" attached for something you didn't order (i.e. a subscription to Norton) with a "button" to press to challenge. And, a button to click to protest.
- 5. You do have a computer problem and don't have GeekSquad's phone number. You "Google" GeekSquad and a web page comes up with a number (another company but worded like the real sit)e.
- 6. You are called about missing jury duty, taxes, a ticket, etc. The caller offers to help.

All the above are dangerous. At the very least, responding verifies your email address (addresses are bought and sold). At the worst, you may be tricked into turning over your control of computer or turning over money. *You can do things to protect yourself:* 

- 1. Go to the real company website and verify contact numbers.
- 2. With some email apps you can cursor over the "from" address and compare with your records (i.e. the Branch Roster). Same with "buttons" you are asked to click on.
- 3. Hang up, don't engage in banter.
- 4. Check directly with the County, IRS, City IF you think you MAY have a liability.
- 5. Get out your Roster and phone the person who supposedly emailed you.
- 6. Be careful sending group emails. Use the BCC, or Blind Copies, feature.

The presentation covered other important areas including Passwords and Two-Factor identification and I'll report next month on them.

<u>Geritol for September</u>. September's 's "Geritol" hails from Paso Robles. A VERY hearty Zinfandel from Opolo. Passo Robles has a long wine history and many old vineyards. Ridge started their tradition of seeking out notable vineyards with the Dusi Vineyard from the area. Turley (a very high-end Napa winery) was so enamored with the area they purchased Pesenti Winery and Vineyards (a long-time favorite with Cal Poly students for great cheap wines) to assure access to their vineyards. # "Exceptional SIR Members" by Dave Nigel

John Cooney joined our Branch in December 2018 having been a member of Branch 91 and their 2017 Big Sir. Branch 91 will always be remembered as a driving force behind great joint picnics. John has shared his Branch 91 experience finding speakers with speaker coordinator Alfred Herpe.

John was born in New York City in 1941 when his father was stationed there as an FBI agent during World War II. He grew up in Detroit, where his father was an attorney for Ford Motor Company. John attended the Jesuit high school in Detroit and the University of Notre Dame, where he graduated in 1963. His family relocated to the West Coast, and John attended UCLA Law School, graduating at the height of the draft for the Vietnam War. He entered the Army, wallowing in mud in the Infantry until the Army decided he would be better utilized as a legal officer in the JAG Corps. After four years and seven months (but who's counting?), including 13 months in Southeast Asia, John left the Army and accepted an appointment as an Assistant US Attorney (a federal prosecutor) in San Francisco. After several fulfilling years there, he left government service and worked for the remainder of his career as a trial lawyer representing Bank of America retiring in 2004.

John has two children, and two grandchildren. His daughter lives in Austin, Texas, and his son in Salt Lake City. His first wife and mother of his children, died in 1995 (the greatest sorrow of his life). Later, John was fortunate to meet and. after several years, marry Marilyn, who is well known to our members as she shares her voice and piano at many venues, including at our annual Holiday party.

John's wannabe hobbies include photography and flying (he has a private pilot's license), although the retirement bugaboos of eyesight gone dim and wallet growing thin preclude continuing with either. John is very busy these days socializing with his friends and playing in the San Francisco Banjo Band that performs at Molloy's Tavern in South San Francisco the first Saturday of each month. John is also dedicated to the best interests of Millbrae and actively participates in civic discussions on important issues. He often notes that it is his friendships that keep him going, including, especially, the friends he has made with SIR. We are so proud and fortunate to have John as an active member of our Branch.
