# JULY 16th LUNCHEON MEETING CANCELED DUE TO PANDEMIC

### BIG SIR GREETING JULY 2020

As we sit in our homes during the hottest time of the year we have much to be thankful for. July 4th many will be able to BBQ or visit with family and friends and celebrate the birth of our nation. As SIRS, we can be thankful our number one activity, golf, has been approved for startup again with some revised rules and a full tournament schedule. We can also look forward to the startups in other activities as we receive guidance and clearance from the State Board and various governing bodies. I have emailed State SIRS Governor Ed Benson regarding starting the luncheons again and he advised it is up to each branch to vote to do so, taking into consideration the rules coming from the government and the vendor, in our case Elkhorn. I have polled the Executive Board regarding possibly starting luncheons in July but all those who responded so far, a majority, feel it is too soon due to the higher rate of the virus infection in our county. The Board still has to create, discuss, and vote on the rules for starting the luncheons. I contacted Elkhorn after our executive board meeting this past Monday and they advised the only direction they have been given is that they can only have 100 people in the entire banquet room, which is currently divided between our luncheon and a women's bridge group. The women's bridge group has around 100 by itself so we may end up having to change our luncheon day if they book first. The only other requirement from Elkhorn is that the buffet line is gone and plates will be filled in the kitchen and brought to each table by food servers. At the very least it is likely that we will all be wearing masks when

not eating and there may only be four per table. Elkhorn advised they have no problem with setting up the extra tables. I have been informed by the Lodi Big SIR that they are already starting up their luncheons at Elkhorn and I will touch base with him after they have their first one to see how it goes.

For now, everyone stay safe and keep up the social distancing and other protective measures regarding sterilization and hopefully we can all break bread together again soon.

**2. More Evaluations of Videoconferencing Systems.** The link in this article compares and rates many of the video conferencing applications that are currently available. Interestingly, Zoom - the one that some SIR branches are currently using for BEC meetings during the pandemic - was considered the best.

Editor's note again: Read the Branch 46 BEC minutes in this bulletin. We voted not to use Zoom conferences for our BEC meetings.

- **3.** What Is Going On With Google? Did you ever notice that when you request information on a subject from Google, it lists several websites you can go to. It turns out if some of the subjects are about a product or something you can buy, Google can get paid for the advertising. So the government filed a lawsuit that says Google is giving preference to those who pay more, and this is unfair to others who don't. There's a lot of legal problems here and you should read the article to see the government's views. We've always noticed that Google seems to put the website with what we think is the best description on the top of the page.
- **4.** How to block Windows 10 May 2020 update, version 2004, from installing. We won't go into this in any detail, but the bottom line is don't install it until you've read the article and see what you're getting.

### SIR Area 18N Restart Plan May 23,2020

To: Branch 46 BEC Branch 145 BEC

State SIR Golf has placed the responsibility of approving the plan for restarting SIR Golf with the individual branch's BECs. I was advised of this on May 21 at a ZOOM State Golf Committee meeting

1) Activities- Branches 46 and 145 are in the SIR Golf Area 18N (Stockton and Lodi), and I (Bill Rutherford) am the Area Coordinator. I am proposing the following plan to restart golf in the Area, subject to the approval of the individual Branches BECs. Our activities for the remainder of the year 2020 include tournaments at the following golf Courses:

Micke Grove	July 15
Swenson	July 29
Elkhorn	Aug 12
Discovery Bay	Aug 17
Cavanaugh	Aug 26
Castle Oaks	Sept 16
Swenson	Sept 30
The Reserve	Oct 14
Dry Creek	Oct 28
Micke Grove	Nov 11

### Your approval of the plan includes approval of these listed activities.

- 2) Operating procedures (background) will follow the guidelines outlined by the Golf Industries recommendations in the 5 page report "Back2Golf Operations Playbook" attached to this request. Our courses are now operating under a combination of Phase One and Phase two. Our recommended procedures will be working under a combination of those two as their procedures allow.
- 3) Specific procedures
  - a) Signups as normally by person, phone, e-mail and mail-in of the application.
- b) Payments will all be in advance and by check, bank check, or money order. No cash will be handled. No payments will be allowed at the course.
- 3) Specific Procedures (cont'd)

- c) Scorecards will be prepared by the Tournament Chairman by computer, and handed out at check-in. They may be handed out by the Tournament Chairman or the golf course check-in personnel, probably with gloves and mask.
- d) Tee time starts (vs Scramble) will be used in the foreseeable future. Players will check in 10 minutes prior to their tee times and will get their scorecards at that time.
- e) Carts will be issued individually unless the course goes to paired issue at some time in the future. Walkers may be allowed.
- f) Tournaments may be limited to 48 players, depending on golf course policy. Although tee time starts make the 50 person limit questionable.
- g) Social distancing will be maintained on tees and through the green. On the green, it's recommended that a player putt out, but not required.
- h) Scorecards will be returned to the clubhouse and placed in a sealed box to be opened by the Tournament Chairman or the course personnel wearing gloves and mask. The cards may be copied and the copies used for work purposes to reduce exposure from the cards.
- i) Results will be provided by the Tournament Chairman after the event has ended. Prizes will be paid by check from the TC (masked and gloved.

Notes:

1) The August 12 mixed Scramble will not have a following lunch and awards meeting, and 2) The take-out lunch provided by the Discovery Bay personnel will probably continue.
