

Why can't you pick winning stocks?

Example: XYZ Company Price/Earnings (P/E) Ratio is 15 (\$90 price / \$6 million earnings / 1 million shares)

How much profit will
the company earn in
the future?
$$\frac{90}{6} = 15 \leftarrow$$
 What multiple will
investors pay for a dollar
of profit in the future?

How can you predict either of these one year from now?

It's extremely difficult to find the few winners




Choosing an index is also challenging



US Small Cap Indices Annual Return (%)






Indices don't always match their names

What is index reconstitution?

- Updating the components of the index to reflect changes in market cap and other factors based on index methodology criteria
- Generally occurs on a scheduled basis
 - S&P Dow Jones: 3rd Friday of each quarter
 - MSCI: last day in Feb, May, Aug, Nov
 - Russell: last day of June




Reconstitution can impact pricing

Price Pressure into Closing Auction on Reconstitution Days and Overnight Price Reversal after Reconstitution, 2019–2023








Reconstitution can impact pricing
