Our Speaker Stephanie Nevins by Little Sir Frank R. Thomas

Stephanie Nevins, the Water Conservation Administrator at the Alameda County Water District (ACWD), will present information about the current water supply outlook for the Tri-cities area and ACWD's water conservation program, including recommended indoor and outdoor water conservation measures that will help us decrease water use.



Since California's water supply will always be a concern, ACWD has included conservation as a significant component of its comprehensive Integrated Resource Plan (IRP). This plan takes into consideration all factors of water supply as related to the growth and development of the ACWD service area. Along with new supply side alternatives, conservation plays a large part in the water supply picture under the IRP.

In addition, ACWD is one of the signatories of a Memorandum of Understanding between urban water districts from throughout the State of California and a member of the [California Urban Water Conservation Council \(CUWCC\)](http://www.cuwcc.org). Through the CUWCC, ACWD joins a statewide partnership of urban water agencies, public interest organizations and private entities to better plan and manage California's water resources.

Ms. Nevins has managed ACWD's water conservation program for almost four years. She has an M.S. in Environmental Management from the University of San Francisco and a B.A. in Political Science from the University of California, Berkeley.

Treasurer's Report

Members of Branch 59, in general, don't pay attention to branch finances. When they enjoy a good meal and a good speaker they may think the price is right. On the days that one of their less favorite meals is served or when they can't hear the speaker they may think they are paying too much.

During any year \$40,000 to \$50,000 dollars is received and disbursed for a number of purposes. The graph at the bottom of the page shows income and expenses for the entire year of 2008. The lighter (yellow) bar shows the income for each month and the darker (blue) bar shows the expense for each month.

What the chart does not show is the distribution of those funds. More detail is shown in the table below. Our finances are broken down into "Custodial Accounts" and "General Accounts."

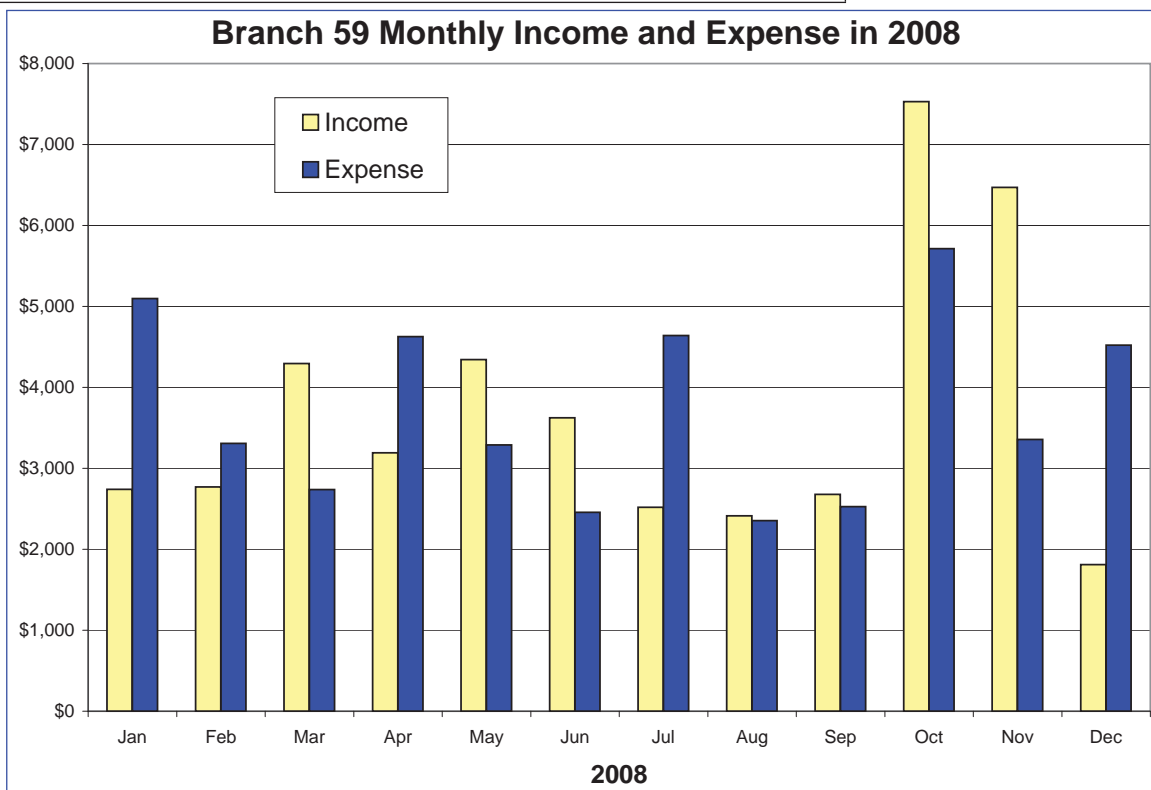
Custodial accounts, as the name implies, handles the funds that are for a specific purpose. Over 52% of the money received and disbursed by the treasurer is to cover the cost of the monthly luncheon meal, the hall and setup of tables. The next Special Activity account covers 18% of the money handled for the Ladies Day events in a similar fashion. The treasurer also receives and pays out money for the Golf Committee, the Bowling Committee and the Caps and Emblems Committee. These accounts deal with a little over 20% of funds.

General Accounts that the board can spend, accounts for less than 9% of the 2008 funds. The largest outlay (~5%) is for the printing of the Annual Roster and the "The Pathfinder" and postage to mail out the newsletter. We spend a little over 2% to cover the State Board Pro Rata Assessment.

This past year the board approved the expenditure of about 1% (\$344) for a new projection screen that has made it more enjoyable to view presentations made by our speakers.

It is my hope that as the year progresses we will be monitoring all aspects of our income as well as our expenses to insure that we continue to function as a well funded SIR organization. We look forward to getting your comments and thoughts on how we can make Branch 59 a more viable and successful "Retirement Association."
