

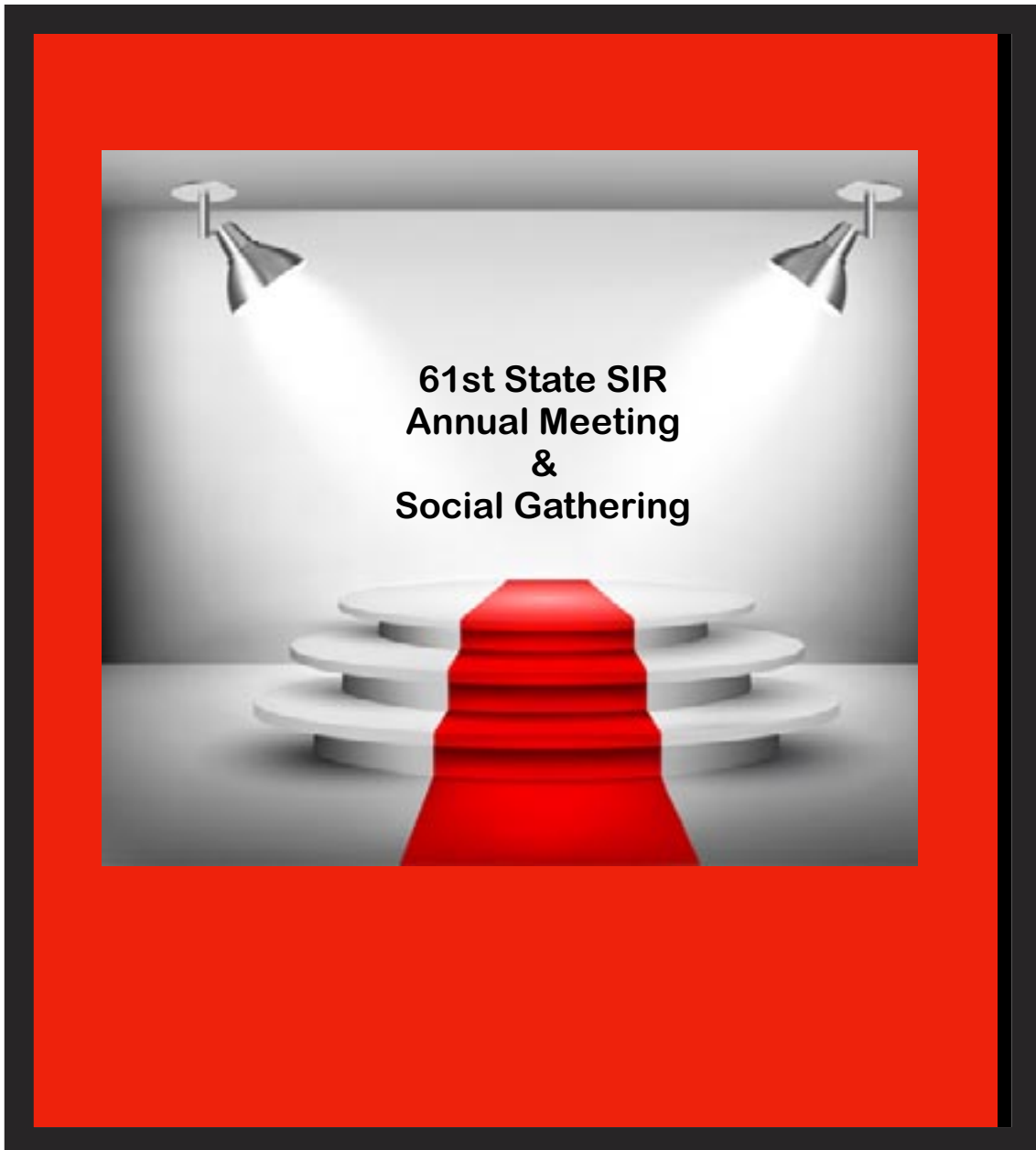

State SIR Board Meeting

SIR Leaders Meet

August 18th through the 20th brought many of our SIR Leaders together at the Thunder Valley Resort Casino in Lincoln.

The social events started off on the 18th with a small but hardy group visiting three wineries near Lincoln. If you happen to be in the area it is a fun way to spend an afternoon. We were impressed with the quality of the wines we tasted, And, to top it off, the tastings were either free or a very low cost with the fee applied against any purchase.

Next up was the kickoff wine and cheese reception in the President's suite, followed by a no host dinner at the Asian restaurant at the Resort.

August 19 began with a State Board meeting. We had 48 SIR Leaders in attendance, and that is the largest gathering for a Board meeting many of us can remember. The meeting's minutes will be posted on sirinc.org shortly. While we were meeting, our partners were entertained with a visit and lunch to the Galeria in Roseville.

Social events after the meeting included another wine and cheese event in the President's suite, an appetizer and beverage event at the Resort and a no host group dinner at The Buffet at Thunder Valley.

Tuesday morning led off with the 61st SIR Annual Meeting. Over 150 State and Branch Leaders attended. The slides used at the meeting are posted on sirinc.org. Take a look at them, we think you'll find them interesting. The business section covered the election of State Officers for 2020 and the passage of numerous, minor Bylaw changes brought about by our recent change from State Rules to Policies and Procedures.

A highlight of the meeting was a talk by Dr. Christine Ritchie, of UCSF who provided us feed back on our recently completed SIR/UCSF survey. At the conclusion of her talk those in attendance could see the value of our participation and partnership with UCSF.

Dr. Ritchie was followed by presentations from State Activity Chairmen and State Administrative Chairmen. Past President Derek brought us up to date on the SIR Foundation. President Ed covered two areas of interest – What the Branches Expect from the State and What the State Expects of the Branches.

The meeting ended in a high note with the announcement of the 2019 SIR Best Branch Awards. Eleven Branches won Area Governor's Awards, and three Honorable Mention Awards were made (Mission Trails Branch 25 – Palo Alto, Westgate Branch 125 – San Jose and San Ramon Valley Branch 128 – San Ramon).

Then it was time to announce the top three SIR Branches. The Second Runner-Up Award went to Arnold Branch 152, and the First-Runner Up Award went to Contra Costa Branch 146 and the Best Branch Winner of the Dwight B. Sale Award, Bidwell Branch 110 – Chico.

Our partners participated in an excellent tour and lunch at High Hand Nursery in Loomis. If you are in the area and have any interest in gardening or outdoor design, it is definitely worth a visit.

After the meeting there was a mixer for those leaders who wanted to stick around and a SIR-wide poker tournament. We will provide more information about the tournament in the next regular issue of Happenings. Both the mixer and the tournament were held before our closing banquet

This is a quick report about the events held over the three days. Many pictures follow taken professionally by our Chief Photographer, Lee Moy. President Ed has received unsolicited positive feedback about the meetings as well as the social events even if they were rather sparsely attended. 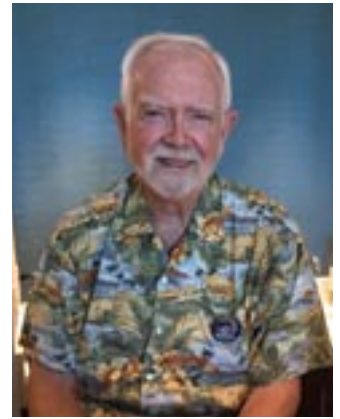

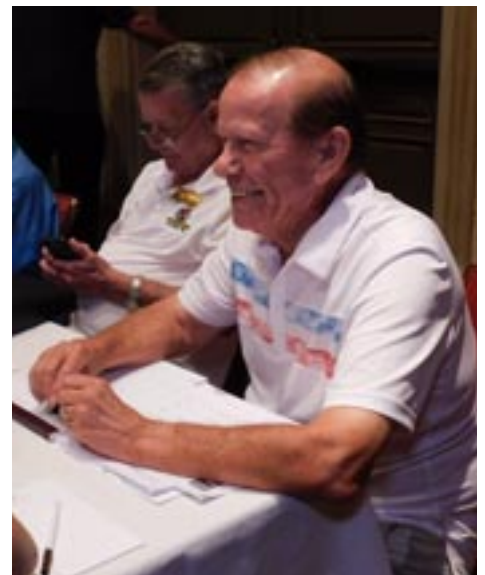
