Our meeting was held on the ZOOM platform, hosted by Jerry Sabo.

Assistant Secretary, Rob Ingebretson, The minutes of the April 21, 2021 meeting were approved after the correction make by Jerry Sabo that Jim Vermazen was present at the April meeting. Big Sir Larry Jett reminded us to review the monthly schedule of branch

operations as it applies to the members involved.

Treasurer, Larry Lardie reported the balance of the general fund was \$2,740.40. Payment this period was \$25.00 for the printing of the Pathfinders that are mailed to some of our members. Larry mentioned a check for the June Bowling Tournament would be forth coming but will deal with this at a later date. Rob Ingebretson brought up that we don't have a 2021 Membership Roster Booklet because of the pandemic. It was decided we will have one for 2022 which will be addressed at a later time.

<u>Big Sir</u>, Larry Jett, his wife Sandy is finally home after spending 16 days in the hospital. She is on oxygen 24/7 until further notice. Larry is grateful for the help his Little Sir Bob Marshall has provided and Bob is ready to take over at anytime he is needed.

Little Sir, Bob Marshall, after a long discussion the three items from the state report dealing with current Covid 19 concerns were accepted and approved by our BEC. The first dealt with branch protocols for Minimizing Covid 19 Liability. The second dealt with a SIR Event Waiver and Release of Liability. Our Walking Group activity has already started to comply with the waiver. Jerry Sabo will send a copy of the waiver form that will be used for Bowling. You can change the heading to use for your particular activity you may be in charge of. The third dealt with logistics for dissemination of Waiver and Release form. The chairman of any activity or event must make sure all participants sign the waiver. Rich Henry will find out how long the chairman of an activity should hold on to the waivers he collects at a state meeting he is going to attend. Upon the return to our monthly meetings at the ELKS Lodge we must make sure that anyone attending has been vaccinated by showing proof with their vaccination record card or be on an updated list of members who have submitted proof of vaccination. It is hoped that eventually this will be recorded in our data base.

With regard to our speakers, Bob informed us of today's speaker, Marie Shadden, who will talk about her military career and the various agencies she has worked for. At our June meeting we will hear from our mayor, Lily Mei. July will be a speaker from Ohlone College addressing our environment. August speaker will address DNA and our ancestry. September our speaker will be a sports guy.
