





Fishing poles and tackle, State of California Cashier's Permit, a 1957 California Registration for the 1956 Pontiac, one long-bladed knife, and insurance policy for the Pontiac.

At Hamilton, CLARENCE ANGLIN, registered at the Cross-Roads Motel on January 21, 1958, using the name CARL W. MILLER and address 10610 New Street, Los Angeles, California. At that time he was driving the 1956 Pontiac, California license MXM 641.


