

#### Fellow Sirs:

I attended the SIR State meeting in Sacramento on August 8th. It was quite lively as new State Officers were elected and the bylaws were amended. In the past, the State Nominating Committee reviewed all of the candidates for each office and came up with a single recommendation. That candidate, and only that candidate, was put on the ballot for a vote by the Big Sirs. Anyone else would have to be included as a write-in. This year a "write-in" candidate for Vice President won and by a fairly wide margin (91 to 30). There was also a write-in candidate for President, but I'm not sure it was real as he was a Past State President (2015), and he did not seem all that serious. I suspect he may have been a part of the show to give the impression that there was going to be a change in the process. It had been a system that promoted the "Old Boys Club" for State Offices. Time will tell if there is change in the works or, it's the same old same old all over again. Now, all qualified and committed candidates, for each office, will go on the ballot for the Big Sirs to select from.

At the State meeting, I brought up that the State should spend more effort to make the public know about SIR. The public does not even know that the SIR Organization exists, let alone what our mission is. I also picked up on some new ideas about what we can do as a branch to recruit new members. I will be bringing them up to the Executive Committee so they can be discussed.

This Year's Christmas Party is scheduled for December 21st. That is quite close to Christmas day and many people will already be gone away for the holidays, me included. I have asked the Board and it has approved moving the party to a week earlier, to the 14th.

Cost for an outside (window) cabin is \$3924 pp/dbl. occ., and a suite is \$5202 pp/dbl. occ. For lowest cost (group travel is more) and maximum flexibility, individual travel can be arranged by the travel agent or arrange your own. Trip presentation – 2 PM, Wed., Sep. 27th at Mama Mia's in Campbell. Please call Jim or Roy to reserve a spot. More information about travel arrangements, cabin upgrades and a discount of 10% is available for those attending the presentation.

I have been assured that, while reconstruction of Mariani's takes place, we will be able to use the facility by adjusting where in the building we meet from time to time. Meanwhile, we are investigating several options that would bring us back to Sunnyvale which is where most of the membership lives. I have previously described the situation at Sunnyvale Golf Course and the Sunnyvale Community Center. Another option is the Shoreline Golf Course (Michael's) which is where the Mountain View Chapter meets. I have contacted them and got a price of \$30 per person--somewhat more than the \$23 we pay at Mariani's now (probably at least \$25 next year). These options may not be acceptable. Keep your eyes and ears open. If you have a thought on the subject, please give me a call.
