Executive Board Meeting of March 16, 2023

Erik Jensen (Club Restaurant Manager) informed us that we'll have to supply him with a head count and meal requests 24 hours ahead of date for Sirs monthly lunches. Bob Rigler said he would mail out an Evite invitation to all members at least a week ahead of each lunch meeting. Ralph Sherer will supply Bob with list of email addresses to be used. Usually there is a choice of meat dish, salmon, or vegetation meal each month. Members would need to RSVP indicating plans for attendance and meal preference. This head count and menu selections would be given to Erik a day ahead of the lunch date.

Al Wuthnow reported we now have \$7,854 in cash on account due to collection of almost all members annual dues. Only two members and one new member have not yet paid their dues.

Dick Robinson sent minutes of Feb 16 Exec Board Meeting to board members and then they were published in the March Horologium. These minutes were approved as reported.

Ken Kauer said he hasn't heard of any sicknesses or health problems.

Robby Robinson is continuing as webmaster but could use help on this job.

Ralph Sherer reported that the new 2023 Roster book was printed and mailed out to all members.

Kelley Reid told us that 3 of the 4 new members attended the March 2 lunch and were presented to the membership. Mark Swartz was not at the March lunch so couldn't be presented as a new member at that time.

Dr Bob Bundy covered the status of merger with Branch 22. Bob said he, Ted Pullen and Dick Robinson attended the Br 22 Exec Board Mtg on March 7. Br 22 currently has 59 members on their rolls and typically get about 35 for lunch meetings on the first Tuesday of the month. The plan is that each branch would keep their officers for this year and then merge into a single branch with one set of officers for next year. We decided that Branch 7 would host a joint lunch with Branch 22 on July 6. Branch 22 holds a backyard picnic in August that our members could attend.

Dr Bob and Michael Sommer listed the speakers we have lined up for the next few months. These
