#### EXECUTIVE COMMITTEE MEETING MINUTES FOR MAY 14<sup>th</sup>, 2020

Committee Officers, Directors, & Advisors absent: Sam Walters; John Sargent; & Chuck McCoy.

Quorum Present: Yes (7of 9 members present when meeting was called to order).

[The last BEC meeting was held in February due to Covid-19. The current meeting in May is being conducted through Zoom technology, with each Committee member participating using their own lap top.

A.Open meeting: The tele-communication meeting was called to order at 7:11 p.m. by Big Sir Mike Conley.

**B.** Big Sir Comments: After calling the Committee to order and welcoming everyone, Big Sir Mike Conley mentioned the problem we're facing regarding the lack of potential officers for 2021. Because of the number of vacant slots that continue to remain open for next year, the future of Branch 94 is coming into question, and the possibility of disbanding the Chapter is becoming real.

**C.** Secretary's Report: The minutes from the BEC's last scheduled meeting in February were reviewed by Committee members and were approved by voice vote without correction.

Little Sir / Membership: Little Sir Julian Luci reported that all his callers were e-mailed a script to use when making calls for the purpose of maintaining contact with the general membership and keeping each member in the loop regarding future meetings, activities available, and the status of our Branch.

Membership Chair Ron Carter asked for updates regarding the status of two members, and will prepare monthly Forms as required.

G. New Business: Regarding the BBQ scheduled for July 16<sup>th</sup>, the majority of the BEC felt that in light of

Covid-19 and the social distancing regulation that most likely will remain in place, that the BBQ for this year will be cancelled and scheduled for some time the following year.

In light of the dilemma we face regarding the open slots projected for next year, June may be the month that we start closing down by giving notice to the State.

#### **Committee Reports:**

- <u>Special Programs</u> Chris Monahan, Special Programs Chair, in light of continuing Shelter-in-Place restrictions, is currently 'up in the air' regarding future speakers.
- <u>Golf</u> Darrell Jones, Branch 94's Golf Chairman, reports that the current golf schedule can be found in the latest edition of the Branch's monthly newsletter.

• <u>Nominating Committee</u>: Nominating Committee Chairman Rich George had nothing new to report. Both he and Big Sir Mike Conley, have tried to appeal to both the general membership and to several others, individually, but no one seems willing to step up and volunteer. While Treasurer Sir Ed Shpiel would be willing to step into the Big Sir role, the position of treasurer would become open, along with the other remaining slots (e,g Little Sir; Secretary and his assistant, assistant treasurer, and assistant membership chair).

### Golf

The Following Golf Participation Plan has been submitted to the Branch 94 BEC. Thirty days after the date of BEC approval, members of Branch 94 may begin to participate in SIR golf activity by accepting the plan.

SIR Branch 94 Golf Branch Rules Of Participation

- 1. The Branch rules of Participation, for all members will reflect the most restrictive golf constraints as published by either the State of California, Santa Clara County and the local golf course to be played. No guests are permitted to SIR sponsored events.
- 2. The ultimate goal is the health and well being of each participant, with the maintenance of 6 feet social distancing at all times being the most critical requirement. Masks and other personal protective equipment are optional unless required by local rules.
- 3. Prior to play, all participants will receive written notice or email message specifying the current rules and constraints under which the golf activity will be played and acknowledge receipt thereof.
- 4. These rules and constraints will be updated as needed to conform to the most current State of California, County and local guidelines.
- 5. During play, all participants should continuously assist each other to remember and abide by the rules and constraints for everyone's safety.
- 6. Any participant failing to abide by the current rules and constraints may be denied further participation.
- 7. These rules will remain in effect until the SIR Branch 94 BEC modifies or terminates them.
