FOR AUGUST 13th, 2020

Committee: Big Sir Mike Conley; Little Sir Julian Luci; Secretary Jim Stonehouse; Treasurer Ed Shpiel.; Directors: Neil Keever, Sam Walters, Rich George, Ron Carter, and John Sargent. Advisors: Chuck McCoy; Darrell Jones (Newspaper Editor); Chris Monahan (Program Chair); Leo Pursley (past Big Sir).

Committee Officers, Directors, & Advisors absent: Sam Walters; Rich George; John Sargent; Chuck McCoy; and Leo Pursley.

Quorum Present: Yes (6 of 9 members present when meeting was called to order).

The current meeting is (again) being conducted through Zoom technology.

A.Open meeting: When everyone was 'connected', the meeting was called to order at 7:05. by Big Sir Mike Conley.

B. Big Sir Comments: After calling the Committee to order and welcoming everyone, Big Sir Mike Conley mentioned that things with the Elks Club are still up in the air regarding covid-19 restrictions, but feels that maybe we might begin to plan for a general meeting for Branch 94 in October. According to his latest message in the Branch newsletter, Big Sir Mike Conley is again asking that Branch members be cognizant of other members who remain 'out there' in limbo, and is asking that each SIR member connect with at least three other members as we continue to shelter in place.

C. Secretary's Report: The minutes from the BEC's last scheduled meeting in July were reviewed by Committee members and were approved by voice vote without correction. Secretary Stonehouse also reported that he is in the process of completing Form 20 regarding a roster of the Administrative Personnel scheduled for 2021--and due by the last day of August at Dwight Sales office.

D. Treasurer's Report:

Treasurer Ed Shpiel submitted Form 28 for review, which was accepted by voice vote by the Committee. While the current balance of our account with Bank America stands at \$2,448, Sir Ed stated that we continue to be charged \$16 a month because our balance falls below \$3,000 (the required minimum).

Little Sir / Membership: Little Sir Julian Luci had nothing to report. However Big Sir Mike Conley stressed to Sir Julian and his callers, that when making contact with their list of members, leaving a message (LM) is not acceptable. Their contact needs to be to a 'live' person. Membership Chair Ron Carter reported no change in membership over the last several months.

F. Old Business: Several open slots still need filling

G. New Business: As things appear to be calming down, it was agreed that Branch 94 will again start scheduling Bocce, starting this coming Thursday, August 30th, at 10:00 at Almaden Lake Park. Sir Julian Luci volunteered to send out an e-mail to those who may be interested. Is there any interest in organizing a Christmas party and all the work that such a luncheon entails? Ron Carter volunteered to send out an e-mail to Branch 94 members as a way of gauging their interest.

Sir Ted Head has agreed to serve as Chairman of the Sunshine Committee. and submitted a one page summary to the Committee as to what his duties would entail. Thank you Ted!

Committee Reports:

- <u>Travel</u> Travel Chairman Paul Berg was not in attendance. However, word has it that the Travel Committee has disbanded—although Branches 39 and 125 still remain active--the Committee is wondering if anything else is being considered in its place, and is hoping that Sir Paul can do some follow up and report back to the Committee.
- <u>Special Programs</u> It has been suggested by the BEC that Chris Monahan, Special Programs Chair, start thinking about lining up speakers for either September or October, but also remain as flexible as possibility.
- Golf Darrell Jones Golf Chairman reported that all State and Area 11 golf tournaments scheduled for the remainder 2020 <u>have been cancelled</u>".
- <u>Newsletter</u> Newsletter Editor Darrell Jones had nothing to report. However, in spite of the lack of Branch news, he will continue to publish a monthly newsletter.
- <u>Nominating Committee</u>: Nominating Committee Chairman Rich George was not in attendance. However, it has been noted that several slots remain open: Assistant Secretary; Treasurer; and Assistant Treasurer.
- Mentioned previously, Ed Shpiel has agreed to be Big Sir for next year; that Julia Luci has agreed to serve one more year as Little Sir; and that Darrell Jenson has agreed to serve as the Assistant
