I. CALL TO ORDER by Big SIR Ed Shpiel at 7:04 PM

a. Present: Ed Shpiel, Big SIR; Ron Carter, Membership Chair; John Sargent, director; Chris Monahan, Program Chair; Ted Head, director; Julian Luci, Little Sir; Neil Keever, Treasurer; Mike Conley, Secretary; Darrell Jones, branch webmaster; 7 of the 11 officers and directors, a quorum was present.

b. APPROVAL OF AGENDA. All present had copies of e-mailed agenda e-mailed by Big SIR Shpiel. Motion to approve by Mike Conley/ second by Julian Luci/ approved by unanimous voice vote.

II. OLD BUSINESS

a. Minutes of the January 13, 2021, meeting had been e-mailed and read by BEC Members. Motion to approve by Director Ron Carter, second by Director Ted Head/Approved by unanimous voice vote. b.

c. TREASURER'S REPORT. Treasurer Neil Keever had prepared the Form 28 to send to State SIR. Balance in the Branch account was \$2059.77 with no bill outstanding. Cash on hand \$75,00. Motion to accept by Ted Head/Second by John Sargent/ Approved by unanimous voice Vote.

d. LITTLE SIR REPORT. Julian Luci led discussion of Attendance and the present Callers' making little contact with members and the reasons for low attendance at ZOOM meetings. The Discussion focused on the minimal number of attenders due to lax calling. Replacement callers suggested were Guy Pound and Don Slama. No action was taken.

e. MEMBERSHIP. Chairman Ron Carter indicated that the Form 27 showed 104 members. The Form 20 SIR report had been prepared but needed some detail before sending. All other reports to State SIR are timely. Mike Conley to accept/ second by Ted Head/ approved by unanimous voice vote.

f. In the absence of Rich George there was no RECRUITING report. Big SIR Conley stressed the importance of building a program to develop future leaders.

g. PROGRAM Chairman Chris Monahan spoke highly of guest speaker Russell Downing "a wild photographer of wild life" all around the world. Big Sir Mike will contact him about the ZOOM preparations required. Monthly virtual Branch Monthly Meeting is 1/14/2020 at 7:00 PM.

h. ANNUAL AUDIT Chair Neil Keever reported that the Auditors had Reviewed and Reconciled all Branch accounts for the year 2020. Motion to accept the Audit Report as presented by Big Sir Shpiel Second by Ted Head/approval by unanimous voice vote.

III. NEW BUSINESS

a. Treasurer Keever indicated that moving the Branch 94 account to Union Bank was in process, required a great deal of unforeseen documentation. Moving the account should be accomplished by Neil, Mike and Ed before the next meeting.

b. CHAPTER ANNUAL DUES during the Covid 19 limits were discussed. Two solutions were discussed: 1) require \$25.00 or less annual dues to measure the interest of members in continuing; and 2) waiving until further notice, perhaps in May or June. The motion to take no action was Moved by Ron Carter/Seconded by Julian Luci/ approved by unanimous voice vote.

c. Mike Conley had been notified by Elks Lodge that we must remove our Cabinet from the Lodge to allow them to being refurbishing the facility. Mike Conley, Ed Shpiel and Neil Keever will take charge of that. A pickup Truck is required. Mike will contact member Rob Perkins for more information. Director Sargent was interested in assisting, based on his familiarity with the setup for Branch 74, who merged with #94.

IV. ANNOUNCEMENT.

a. It was announced that long-time Directors Chuck McCoy and Sam Walters have stepped down from the BEC.
