#### Golf Notes

#### Submitted by Darrell Jones

At the August Branch Executive Council meeting, I announced my intentions to resign as golf chairman at the end of 2021, I relunctantly when events caused me to realize that my efforts for the club were not succeding. In January 2020, before the Covid epidemic, there were approximatily 17 members of the Branch 94 golf group. With the departure of Ron Carter, we are down to 7 members. For the first two area tournaments of 2021, we were able to field one 4 man team. For the third 2021 tournament at Pacific Grove, which I hosted, I was the only Branch 94 particityants. There has been one change to my planning since the last BEC meeting. The Pacific Grove tournament was a success. We had ten 4 member teams participate. After the tournament, Ray Gilcrest. The Area 11 Golf Chairman asked Branch 94 to host the first 2022 tournament at Spring Valley in February. I agreed, so I plan to continue with this assignment until the February tournament is complete or I have been repalced as the Branch 54 Golf Chairman.

In the last few days, there have been several significant development that will affect every Branch 94 golfer. First, I received an email from the NCGA on September 10. The following is a quote of the pertinent portions.

"I am reaching out to you with some urgency regarding the status of your club's membership with the NCGA.

In short, the USGA requires a minimum of 10 members in order for a club to issue handicaps. Likewise, NCGA bylaws require this same minimum headcount.

At present, your Sirs Branch membership stands at only eight members.

In upcoming weeks it will be necessary for your club to both reach this 10-member threshold, and maintain such a level moving forward. In fact, the USGA is compelling us to enforce the requirement.

At the end of each quarter the USGA performs an audit of our membership looking for clubs that a) have not yet completed the required handicapping education and passed the necessary quiz (you satisfied this requirement on behalf of your club); and b) have fewer than 10 members. If a club fails three consecutive quarterly audits, we are forced to inactivate that club.

As things currently stand, your club is on pace to fail its third consecutive audit in a matter of weeks."

Once we are inactivated, our members will not be able to obtain their NCGA/GHIN ID from Branch 94. For that reason, I checked with the other branches in Area 11 for other options. I received 2 responses which you may find helpful.

#### From Branch 125, Ray Gilcrest::

"Hi Darrell, Branch125 would be more then happy the accept all 7 in to the Branch and Golf Club. The Branch has there luncheon on the third Tuesday of the month at The Three Flames in San Jose. Our Golf Club plays every Wednesday. Your golfers are more then welcome to play with our club some Wednesday too see how the could fit in and also come to one of our Tuesday luncheons"

#### From Branch 32. Rick Hausman:

"We would welcome any golfers. We play on Tuesdays at Los Lagos and have from 3 to 5 foursomes. We have 1-3 foursomes that play at Spring Valley on Fridays. There are 20-30 (co-ed) who travel to most of the State SIR Tournaments (Napa, Reno, Championship).

We would eagerly welcome additions to the Branch, especially the golf group. I will be Little SIR next year and Big SIR the year after! I would be happy to have anyone as my guest at our live luncheon which we have reinstated at Three Flames on Meridian on the third Wednesday of each month (must have proof of vaccination and sign SIR Covid Waiver form).

Let me know if you need more info and I would be glad to talk/meet with anyone interested, and/or have them come to the luncheon!"

I am not advocating that any member leave Branch 94, I am just informing the golfers of some opportunites to continue to maintain their NCGA/GHIN ID and play more SIR golf. I personally joined SIR to play golf. Therefore, I do expect to transfer to one of these branches in the near future. -ed
