OUR NEIGHBORS RELIGION SEVEN WONDERS OF JEW-ISH HISTORY by Rabbi Spiro

What it would take to constitute a perfect world? Ken Spiro questioned more than 1,500 people of various backgrounds, revealing six core elements: respect for human life; peace and harmony; justice and equality; education; family; and social responsibility. A highly readable and welldocumented book about the origins of values and virtues in Western civilization as influenced by the Greeks, Romans, Christians, Muslims and, most significantly, the Jews.
