days and unusually warm evenings. Ahh, just another Sacramento-area summer. I hope you found a cool spot with a cool drink to celebrate Memorial Day – the unofficial start of summer – with family and friends.

We're just a few days until California is expected to fully reopen on June 15th. It's been a long haul and particularly brutal on small businesses. It'll be interesting to see if those that barely survived can bounce back quickly. I was contemplating the reopening recently and noted that a few counties remain in the "Red Tier". Only last week did Sacramento County move down one level into the "Orange Tier". So, on June 15th, all of these counties will move from whatever tier they're in to fully open overnight. What will have changed overnight that a county that was heavily restricted on June 14th could presumably go full speed ahead the next day. It seems it calls into question the metrics used in setting the tiers and corresponding restrictions. Perhaps we should have been using the weeks leading up to the 15th to step down each county's tier level. I'm not trying to go political on you nor am I saying such emergency steps such as establishing tier restrictions was unnecessary; but, moving overnight from restricted to unrestricted while remaining at a "restricted" tier seems like bad optics and political fodder to those that like to mix it up in the political arena. If Sacramento is listening, expect tier levels to continue to drop in the days leading up to the 15th. Just saying...

### **BIG SIR continued...**

Speaking of reopening, our branch is potentially just a few weeks away from returning to all indoor and outdoor activities. This means the resumption of in-person lunches at Empire Ranch, golfers potentially being able to meet in the clubhouse before and after a tournament to kibitz or have a bite to eat and planning for our Ladies Day Picnic. Currently, reopening depends on Empire Ranch working out some staffing issues in their restaurant and convincing the BEC that our members will have a good experience with whatever ongoing restrictions may be imposed on them by Sacramento County. To hedge my bet, I've reserved our usual time slot on Zoom through August. I can always (and hope to) cancel.

Reopening also depends on our branch meeting State SIRs reopening protocols. On that front, I'm happy to report that 64% of our members have returned their signed Waiver and Vaccine Certification form. To those who haven't signed the form yet, there's still time and I encourage you to do so. Otherwise, to be able to attend our lunches or any other indoor event, you will either have to show one-time proof that you have been fully vaccinated or, for each indoor event you attend, that you've tested negative within the three days prior to the event. There's no vaccination requirement for strictly outdoor events. Therefore, attendance at the picnic for members and their guests only requires signing the waiver portion of the form. If you've misplaced a copy of the form, I'll be sending out a targeted reminder with a copy of the form in the next few days to those who haven't yet sent in the signed form.

State SIR held its leadership training last month for Big SIRs. As expected, the focus was on reopening, rebuilding branches by increasing membership, increasing the number of activities based on surveying members' interests and increasing volunteerism by building a pipeline of capable and willing members to fill key branch positions. To the last point, I'm happy to report that our 2022 slate of BEC candidates is nearly complete. One key and necessary unfilled position is Little SIR. Please let me know if you are interested in setting the direction of and continued growth of our branch by being part of the branch leadership team and I can provide you the job description. Remember that active volunteerism is part of the deal when you join an organization like SIR and is integral to a branch's ability to stay in existence.

State SIR is also focused on branding. They hired a marketing consultant whose biggest finding was that there is no consistency in the messaging from one branch to the next.

This month our speaker will be Mr. Michael Roberts. Mr. Roberts arrived in El Dorado County in 1989 and joined the board of the Clarksville Historical Society in 2013. He originally hails from the Midwest, having graduated from Northern Illinois University in 1978 with a BA in Psychology, a BS in Sociology and a halfmaster's degree in data processing. In 1979 he moved to San Francisco where he worked for Gap Inc. doing systems design for the next eleven years. After arriving in El Dorado County, he spent another eleven vears working for Sacramento Business Machines. There he helped Sacramento Business Machines become POS Resources. He brought in strategic platforms from IBM and later Microsoft to design innovative programs for the wine industry and others. In 2003 Michael left POS Resources and started taking courses in fiction writing, digital imaging, and website design. In 2004 he spent a year with a small EDH web design company, Software Carpenters and in 2005 managed an art gallery in Town Center that brought him an awareness of and profound interest in Clarksville. His retirement activities include work on his 3-acre homestead in Placerville, his involvement with the Clarksville Historical Society, and his interest and study of wagon trail history and especially his studies of historical cemeteries.

Mr. Robert's talk to our group is titled, "Clarksville, A Ghost Town in El Dorado County." Before El Dorado Hills, and sometime after, there was Clarksville. It still appears on maps, and in fact stands today – barely –as a ghost town, east of the Silva Valley interchange. It is straddling some of the historic transportation corridors that determined its destiny: the original Highway 50 alignment; the Lincoln Highway; and the Old Mills Hangtown Road, the original rout from Sacramento east to Placerville. For a century-and-a-half, Clarksville's fate has been inextricably bound to the transportation corridors it served, and those it did not. Mr. Roberts talk will elaborate on the history of Clarksville and the impact transportation had on the birth and the demise of this historic place.


