The May 19th wine tasting event was held at the home of Kevin and Marsha King. There were threeand one-half couples in attendance. The featured varietal this month was California

Zinfandel. The selections where interesting as three of the four wines were from Sonoma, two were from the same winery and the winner was from Amador County. As always, all the wines were very good and trying to pick a winner was a challenge. Here are this month's results:

- 4th place 2017 Rodney Strong Old Vines Zinfandel, Sonoma County (\$19);
- 3rd place 2019 Seghesio Family Vineyards Zinfandel, Sonoma (\$22);
- 2nd place 2017 Seghesio Old Vines Sonoma Zinfandel (\$35); and
- 1st place by a good margin Newsome Harlow 2019 Shake Ridge Ranch, Amador County Zinfandel (\$27).

A delicious potluck followed the wine tasting. The dishes included a perfectly done Tri-tip roast, a fresh green salad, a yummy corn and squash casserole (a must- have second helping), a potato casserole and all was topped off with a chocolate Coeur de Crème with

a Melba sauce. The desert was paired with a Macchia 2013 vintage port from Amador County.
