On August 25th, 2022, I attended my first State SIR Annual Meeting. As the date approached, I must admit I was not eagerly anticipating a lively morning spent on Zoom. Much to my surprise, it held my interest, and I learned a lot that I can share with all of you. Important things are happening in

our organization about which we can be proud.

All Members of the Corporation plus State Committee Chairmen, Branch leadership and invited guests were present via ZOOM. An opening statement was given by our current President, Rick Kindle, and a vote to change certain by-laws was completed without opposition. Our new slate of officers for 2023 were presented. Our new President will be Dave Gonzales from Branch 98 (Roseville/Rocklin), Vice President will be Dale Decker from Branch 136 (Sonora), Chief Administrative Officer will be Roy Hodgkinson Branch 146 (Walnut Creek/ Pleasant Hill), State Secretary will be Russ Salazar Branch 113 (Pollock Pines), and State Treasurer will be Carl Mason Branch 88 (Vallejo). All ran uncontested and all were elected unanimously. Remarks by our President-Elect were given, and he seems like he will do a great job next year.

The Treasurer's Report was given by Roy Hodgkinson. Roy also spoke on Growing the SIR Family. The State SIR organization is now below 10,000 members. In October of 2018 there were 115 active branches. In April Of 2022 there were 96 branches. So, we are losing branches at an average rate of six per year. To help to address this dynamic, the State Board is on track for changing the language in our by-laws to eliminate gender and employment status as criteria

for SIR membership. The Mission Statement will be "Activities for All." This change will allow branches to chart their own course as far as membership goes. The State will not require female membership, but by the change in language the inclusion of female members can be realized by branches that choose to exercise this option. The actual language has not yet been changed in the by-laws, but it will be completed some time in 2023.

The Activities Committee Chairman, Bob Lucido, presented his plan to help branches develop their activities to increase interest in SIR membership which includes working with branch chairmen. This will provide the perfect opportunity for a new Branch 95 Activities Director, which we still need.

The Training and Development Committee Chairman, John Kent, reported his plan to strengthen Branches through leadership training and concentrating efforts on at-risk branches.

Dale Decker, Vice-president, and Region 2 Director presented a newly defined and expanded system of awards and recognition to recognize members that are truly doing work above and beyond to support SIR at all levels. The first level of recognition is the "I'm Doing My Part" lapel pin. It is presented to branch members that have stepped up to do the jobs that support the local branch. We have been presenting these awards to our members at the monthly luncheon meetings. Among our recipients this year are Kevin King, Terry Starkel, Tim Irish, Ken Mahar and

Lew Chapman. A new Distinguished Service Award, now the second highest award, is earned by those who have clearly earned it through exceptional and extraordinary service for three years or more. Only one for every twenty-five members of a branch can be awarded this award. Finally, there is a continuation of the highest award, The Honorary Life Member award. This award is earned by those who have clearly made it through exceptional and extraordinary service for five years or longer. This award is limited to 1 for every 50 members of a branch. Currently, we do not have any Distinguished Service Award recipients or an Honorary Life Member recipient. Please think about deserving members you would like to nominate for one of these awards which can be given at any point during the year. The top two awards must be awarded through State Board approval.

Mv All-Time Favorite Book

Don't know much about history... remember that 1960 song by Sam Cooke?

I wasn't much of a history person until the second half of my life, but then I discovered The Discoverers by Daniel Boorstin.

Daniel Joseph Boorstin (October 1, 1914 - February 28, 2004) was an American historian at the University of Chicago who wrote on many topics in American and world history. He was appointed the twelfth Librarian of the United States Congress in 1975 and served until 1987. The Discoverers was a national bestseller when it was published in 1983. The subtitle is "A History of Man's Search to Know His World and Himself."

I learned more from the book than any other I have ever read. I highly, highly recommend it. Fair warning, it is an intellectually challenging book. I had to reread several chapters to get the concepts starting from his recounting of the invention of time, the invention of math, the development of religions and development of basic scientific paradigms, etc. I am on my third reread of this--my favorite book of all time and enjoying and learning as much as I did the first time.

Boorstin asks and addresses questions like: Why didn't the Chinese discover Europe or America? Why didn't the Arabs circumnavigate Africa and the world? Why did people begin to believe that there are "species" of plants and animals? Why were the facts of prehistory and the discovery of the progress of civilization so slow in coming? I'll try to make sure there is a copy of this great book in our exchange at our next luncheon.

This book is a part of a trilogy by Boorstin and is followed by The Creators and The Seekers. Also excellent and enlightening books.

So, remember the benefits of our SIR Book Exchange: No cost, no library cards, no late notices, no fines.

Finally--I write these articles about the Book Exchange to encourage participation. Please take as many books as you like. So far we are not getting too much action, so I'm considering lugging the books in less often (every other luncheon) Let me know what you think. The August 18th wine tasting event was held at the home of George and Micki Alboff. There were five couples in attendance.

The featured wine this month was red blends. There was no specificity

as to the region, country, or type of bend. Though the blends were different, they were all very good.

First Place with 32 points was a 2019 Ridge Three Valleys from Sonoma County (\$27). The blend consisted of 75% Zinn, 13% Petit Sirah, 10% Carignane, 3% Murtado and 1% Alicante Bouschet.

Second Place with 30 points was a 2016 Dueling Pistols (\$20). The blend was Zinn and Sirah.

Third Place with 25 points was Vengeance 2018 Napa Valley Red Blend (\$25). The blend consisted of Zinn, Sirah, Merlot and Cabernet.

Fourth Place with 13 points was a Justin 2019 Savant from Paso Robles (\$44). The blend was Cabernet and Syrah.

Fifth Place with 0 points was 2018 Terre Forte-Clauancard French Bordeaux Blend (\$17).

A potluck dinner followed the wine tasting. The dishes included lamb kebabs, rice pilaf, a greens and fruit salad and a wonderful peach tart.
