

A reminder, if you have not yet let me know of your intentions to participate in SIR Branch 95 golf for next year, please do so soon. At the time I am writing this, we have had 20 players let me know they plan to renew for next year. 15 of them have already paid and 2 members have informed me they will not be renewing with us next year. That leaves guite a few that I am not sure about. I know several in our group have health issues that keep them from participating as much they would like. Please let me know by mid-December. I will be sending out reminders before then, with a list of those that have renewed. Before next season starts, I would suggest everyone review the USGA golf rules. I am not aware of any changes yet for next year, but there are usually some. As for SIR Branch 95, I will be sending out updated rules before we start our new season. To speed up play, play ready golf. Have your club selected and be in position to play when it is your turn. If someone is on the other side of the fairway you may want to go ahead and hit your ball, even if you are a little closer. If someone is raking the bunker, you may want to have your group putt while the raking is being done, instead of waiting for him to finish and then come to the putting surface. Since we can move the ball six inches when it is not in a hazard or on the putting surface, you may also consider it as lift, clean and place whenever we play. Do not spend more than 3 minutes looking for a ball. Try to keep an eye out for the golf balls of others in your group. Our depth perception and eyesight is not as good as it once was and we can all use help keeping track of the ball.

So, as those of you who read my Book Exchange article each month know, I write some sort of book report on what I have been reading. I'm still plowing through two big reads from the

past few months, so I have nothing new to report on. Therefore, I decided to do a little research on other people's reading and came across this on Microsoft Edge, and that is Bill Gates recommended holiday reading. I am an admirer of Bill Gates, his Gates Foundation work, etc.



These seemed pretty interesting, here goes:

The first one he recommends is "The Song of the Cell" by Siddhartha Mukherjee MD. It's right up my alley. Mukherjee, a Pulitzer Prize-winning author, and Columbia University oncologist, writes here about what Gates calls "the building blocks of life" — the cells that make up all living organisms.

In one sense, "The Song of the Cell" is a medical history, covering the discovery of cells in the 1600s and how people's understanding of them has evolved over time. The book, published last year, is also a look ahead to the future medical breakthroughs that cellular manipulation could unlock.

The next one is "Not the End of the World" by Hannah Ritchie. How about a little climate optimism to get you into the holiday spirit? "Everyone who wants to have an informed conversation about climate change should read this book," Gates wrote.

Finally, he recommends "Invention and Innovation" by Vaclav Smil. Smil, a professor emeritus of environmental science at the University of Manitoba, is <u>one of Gates' favorite authors</u>. Gates said he's read every single one of Smil's 44 books, and that "nobody is better than Smil at explaining the past."

Now mind you, Gates is a connected guy, and he gets to pre-read some books so the last two are books that will be published early in 2024. I'll will do my best to get copies of them and get them into the Book Exchange.
