EXPERTISE: Water policy, climate change policy

Jeffrey Mount is a senior fellow at the PPIC Water Policy Center. He is an emeritus professor of earth and planetary sciences and founding director of the Center for Watershed Sciences at the University of California, Davis. A geomorphologist who specializes in the study of rivers, streams and wetlands, his research focuses on integrated water resource management, flood management and improving aquatic ecosystem health. He has served on many state and federal boards and commissions that address water resource management issues in the West. He has published more than a hundred articles, books and other publications, including the seminal book *California Rivers and Streams* (UC Press). He holds a PhD and MS in earth sciences from the University of California, Santa Cruz.

- Are there other activities you're interested in that you believe other members would enjoy?



The 2024 SIR 95 golf season is coming soon. Our first scheduled golf will be at Empire Ranch on Tuesday, February 6, 2024, with the first tee time at 11:20 am. This year we have 39 rounds of golf scheduled at nine different courses. The Club Championship will be held in September this year after having been changed to October

this past year due to the maintenance conflicts at the courses. Our season will end at Mather on December 10, 2024.

Because of the increase and restructuring of the NCGA dues, our dues went up to \$55 this year. That is what it was about six years ago when we reduced it to \$50. We will have a few special format rounds this year, all of which will be team events with additional prize money added to the pot.

The new schedules will be sent out in early January along with some SIR 95 rule revisions/clarifications. A reminder that for all SIR 95 golf events, the tournament director will adjust and post the scores. For individual play on your own, each member should be posting their score to NCGA to keep the handicaps accurate.

We can always look forward to enjoying the company of our fellow SIR golf members as we work our way around the courses and meet afterward in the clubhouse. From my previous Book Exchange article, I finally finished reading Slovakland. It does not end well. And I'm still going through Indigenous Continent. More on that when I finally finish it.



Branch 65 and Napa Bowl will host the first tournament of the New Year on January 16-17. This will be a singles/doubles event in which you can bowl both events on one day, or like Cindy and I, drive and

bowl one event in the afternoon, spend a night, and bowl the next event the following morning. We always enjoy having dinner with fellow SIRs that travel with us accompanied by some that are local to the area. Doing this allows us to drive home earlier in the day avoiding rush hour traffic.

Napa Bowl is one of only fifteen centers in the nation that have installed USBC-certified string pin setters. USBC has done much research on bowler scoring between free fall and string pin setters which indicate a minimal difference in averages. Those findings will allow bowlers to use their current average in tournaments with string pin setters. I look forward to testing this theory!

February 15-16 we will be bowling a tournament hosted by Branch 69 held at Country Club Lanes in Sacramento. This has been a very popular tournament drawing one of largest groups of SIRs. Interestingly enough, some of the lanes at Country Club also have string pin setters; however, they are not USBC certified and we will not be using those lanes. With this one so close to home, you won't want to miss it!
