WHY VOLUNTEER? | Kevin King, PBS; HLM 916-337-9811

Last month, Lew reported that I had been nominated to be the State SIR's Chief Information Officer (CIO) in 2025. Well, the vote was taken at the State Annual meeting and it's official. I will assume that role in January. Before thinking I've gone to the dark side, I want to give you some background and then I'm going to challenge you.

A few years ago, I came across a State report indicating our branch was a declining branch and destined to fail. Why? We had declining membership over a five year period, the median age of our branch was increasing, we didn't offer enough activities and we had difficulty filling our board positions every year. As Big SIR at the time, I took great offense to this study and set out to set State straight.

I was able to show State leaders that we were performing as well and often even better than much larger and much more highly touted branches in dense population centers. I made several presentations at State meetings showing what we were doing to turn our Branch around and State has adopted and is promoting many of our ideas. I guess doing all of this put me on State SIR's radar and the invitation to join the State board. It's also put our Branch in the spotlight. I can assure you that we are now seen by State SIR as a highly successful Branch and other branches are emulating what we are doing.

Our Branch leadership the past few years are largely responsible for this transformation. The numbers speak for themselves. Our membership has rebounded from a post-COVID low of 68 to our current 102 with three more members to be inducted at our October meeting. Are you aware that our branch has added at least one new member, and as many as six new members, in all but four months since the start of 2022? Our branch is also getting "younger" as we currently have three members in their fifties and another twelve in their sixties. This has helped bring our members' median age down to 77. Under Jay's and Lew's leadership the past three years, we have 3-4 times the number of activities today than we had before COVID struck.

However, there is one area where we continue to struggle. Our Branch does not have much bench strength or a pipeline of volunteers ready to assume Branch leadership positions. Not having members step up to fill critical BEC and activity chair positions is a perennial problem. Oftentimes we can't present a full slate of candidates for BEC positions until the eleventh hour - months after that information must be provided to State. Granted, the lack of volunteers is not unique to our Branch. Even at the State level, I once counted 130+ named positions at State. Shockingly, less than 40 people fill those positions oftentimes filling 2-3 positions. Volunteerism at the branch and State level is a real problem - one that State is actively trying to deal with. So, why did I volunteer to become CIO? Well, because there was a need and I thought I could leverage my technical and organizational skills in that position. I also wanted to be the eyes and ears for our Branch at State so I could head off any concerns about our Branch and other, similarly situated branches. Simply put, I wanted to have a voice at the table to help shape the organization.

Why did you join SIR? For the majority of members in most branches - including ours - it's for golf. Where else can you play weekly with your friends at all of these fabulous courses and not have to setup your own tee time? However, for non-golfers, what's your reason? Is it the monthly lunches and the interesting speakers? Is it our other activities that keep you - and oftentimes your spouse or significant other - socially and physically active? Is it because of the network of friends you've made over the years? What if it was taken away because we couldn't find enough interested members to keep our Branch going?

Did you know that each SIR branch is a California corporation? By being a California corporation, we must conduct ourselves like any other corporation in the State. This means that it's expected that we have a full set of corporate officers (our Branch Executive Committee or BEC), that the BEC keeps financial records and meets regularly (the BEC meets monthly prior to our lunch meetings), that the decisions made by the BEC are documented (the minutes of the BEC meeting) and that we pay taxes (handled by the State for all branches). If we don't fulfill our Corporate obligations, the State of California can shut us down. If we can't fill the bare minimum of BEC positions that State SIR requires, State SIR can move to have us merge with another branch or, in the most extreme situation, revoke our charter. Like I asked before, what would you do if our Branch no longer existed?

Like Patterson and Crighton, David Baldacci is one of my favorite authors. He is incredibly prolific, where do these guys get so many imaginative ideas? They all tend to write books in themes or series. The one I just started is called the Atlee Pine Series. Actually, I made a mistake and read the last in the series first called Mercy. Now I'm back to the first in the series called Long Road to Mercy. I think the story will start to have a little more context now.

Anyway, Atlee Pine is an FBI agent with special skills assigned to the remote wilds of the southwestern US. As a child, her twin sister is abducted, and among her FBI assignments, she continues to search for her sister who has been missing nearly 30 years. This first book starts by investigating the killing of one of the Grand Canyon's commercial pack mules at the bottom of the Canyon, and the lost person who rode it down to Phantom Ranch. But the missing person is not just some random tourist, and the mystery begins.

WINE TASTING GROUP | Jay Muzio, PBS 650-302-1902



This month the wine tasting group met at the wonderfully eclectic home of DJ and Judi Peterson. Situated on a westward facing hill, the home afforded the attendees a spectacular sunset.

The featured varietal was Chianti. Chianti must be at least 70% Sangiovese. Chianti Classico must be at least 80% Sangiovese and aged for seven months in oak barrels, Chianti Riserva wines are aged for 24 months and top-of-the-line Chianti Superiore or Grand Selezione must be aged for 30 months.



In many of our tastings we have had duplicate bottles presented for evaluation. In past tastings, the very same wine often was rated, for instance, first and seventh. This month we had two presentations of St Giorgio, 2017, Chianti Riserva. The amazing thing this month is that the bottles rated first and second and were only separated by one point. I guess our palates are getting better with practice. The other wines this month, in no particular order, were: Renieri 2020 Gran Selezione, Uggiano 2019 Chianti Classico, Figli d'Italia 2018 Chianti Reserva, Santa Margherita 2021 Chianti Reserva, Borgaio 2020 Chianti Reserva, Kirkland 2021 Chianti Reserva, and Tenuta Di Renieri Chianti Reserva. All the wines were excellent examples of Tuscan Chiantis.



The tasting was followed by a tasty trio of lasagnas made by Judi, accompanied by the usual wonderful side dishes and desserts that have characterized our exciting wine tasting events. And, as an additional attraction, a good friend of Judi's and DJ's, serenaded us with lively Italian music on his accordion.

We had two first time participants this month, David and Charise Tom as well as Jeff and Pam Jarvis. Our group continues to grow. 

There were some guys intending to transfer to Branch 95 from branches in the Bay Area, there were guys that had just moved into the area looking for connections and activities and there were ladies looking for something to get the old guy out of the house. It was eye-opening how many people have not heard of us and were interested in the socialization opportunity we provide men.
