Our SIR Branch 95 Holiday Dinner is Coming!

Hello everyone!

Our November speaker will be our own Harry Hall. His topic will be "The Case for Nuclear Energy". More information about Harry is available in the Member Profile section which begins on the next page.

Last month, John Hidahl, El Dorado County District 1 Supervisor, spoke to us about County government and future plans for the County. Harry Hall provided a summary of his talk:

- County Supervisors have term limits of 2-4 year terms
- County staff has no term limits. This creates a division between the elected officials and the staff on directions the county should go.
- 70% of county income is from property taxes; 44.8% Property taxes goes to state and education. The County gets 23%. The rest goes to areas like El Dorado Irrigation District.
- El Dorado County has a 7.75% sales tax. Of this, the county receives 1.25%. Sales tax is NOT keeping up with inflation. For example, bike paths have increased in cost from \$1 million/mile to \$1.5 million/mile in the last 5 years. He admitted that they like bike paths because they do receive grants from the State. The State is trying to encourage folks to ride bikes or walk instead of driving.

- Increases in fire insurance have hurt home sales, which in turn has hurt income to the County.
- It's looking as though the Costco at Silva Valley is a go. There will be fuel pumps also. Having Costco in the County provides an opportunity to stop the bleed in sales taxes to Sacramento County.
- Town & Country at Bass Lake Road & HW 50 will have two new hotels and cottages...again extra County income.
- There are 58 counties in CA. Of these, 28 are Charter Counties. EDC IS a charter County. Charter counties have more expensive retirement packages. There are "seven" elected positions in EDC. Of these; Supervisors, Surveyor, Sheriff, tax collector, etc. WE are the only county in the state that has an elected position of Surveyor.
- El Dorado County has a yearly budget of \$1 billion/yr. Of this, \$300,000-\$400,000 is considered discretionary. 17% goes to El Dorado County Fire Departments. State helps with road maintenance, but IF we want to increase size or add new roads, state does NOT help with it.
- When asked, Hidahl admits that he likes the idea of incorporating El Dorado Hills into a city. He admitted running a previous committee that reviewed this. He has previously said, and in this talk, wants growth. He sees growth as a way of keeping up with growing expenses.
- He indicated that the County Supervisors hold monthly, public meetings, generally on the 1st Monday of the month. Meetings usually starts at 5:00pm and are held at the Fire Station on Harbor Blvd in the conference room. Along with all 5 supervisors, the Sheriff, CHP and Fire Department send representatives.

This was the first talk that I had attended from Hidahl. He is an impressive speaker, had good graphics and obviously knows his facts. However, he comes directly into conflict with citizens who want to keep El Dorado Hills more rural.


Finally, it's not too early to mark your calendar for our annual Holiday Dinner. Below are the pertinent things you need to know:

MEMBER PROFILE | Lew Chapman, Big SIR 510-912-5658

This article will be an ongoing feature of our SIR Branch 95 newsletter. We would like to include a member profile in the monthly newsletter as well as have a member speak about themselves at our monthly luncheons. In this way, we will get to know about 20 members, over the course of a year, in a more detailed way.



This month's profile is about Harry Hall based on an interview conducted by Lew Chapman.

"I believe in continuous learning. I am an avid reader, and I like to stay active", said Harry. Harry is going to be our speaker this

month on the topic of nuclear energy. While he worked in the energy industry, Harry was self-taught in numerous areas, including nuclear energy. He has written many short articles about the oil industry and other topics such as climate change and other general interest topics such as immigration, life before technology and life after retirement - some of which have appeared in oil industry magazines and other on line sites like AMAC. He also became interested in providing talks to retirement groups like SIRs, Sirtoma, Rotary, Chevron Retirees Association, etc. He estimates that he has given over 20 talks over the last 10 years, mainly to SIR chapters in the Sacramento Harry has previously taught Adult Sunday School class in Texas, was an active Board member (treasurer) of his HOA in TX and Concord, sang in his Church choir in both Texas and Concord, was Treasurer for several years in the Clayton Valley Little League, a Soccer referee during his two son's public education in Concord and was a Deacon at his church in Concord. Clearly a very involved kind of guy.

A professional Chemical Engineer, Harry Hall has spent over 50 years in the Oil Industry - 33 of them with Chevron, before retiring as the Manager of Product Engineering (PED) in 2004. PED set the Chevron fuel specifications for all of its fuels and was responsible for making sure that Chevron met the fuel quality claims that it made to the public. When Harry ran the department, they did fuel comparisons to know how Chevron gasoline matched up with the competition ("no one better").

Harry has worked in several refineries and chemical plants and is proud of refining's important contributions to our modern society. He has worked previously in concert with the EPA, OSHA,

Environmentalists and other oil companies (API) to provide cleaner fuels for today's vehicles and in improving the safety record of refining. He previously was Chevron's Board member to the Coordinating Research Council (CRC), which is a joint Auto/Oil effort to provide research on improving both the fuels and vehicles of tomorrow.

Harry lived in the San Francisco East Bay (Concord/Clayton) for most of his career. At the end of his time with Chevron, he decided to relocate to Texas. They stayed in the Dallas/Ft Worth area for 8 years...and then came their grandchildren. They moved back to California and selected El Dorado Hills to be close to his family. His kids/grandkids reside in NorCal so it made sense to be close—read on. When he retired from Chevron in 2004, Harry formed a small consulting company, HLH Consulting, LLC, where he provided engineering consulting to the oil and chemical industries. He finally fully retired in 2019, as COVID stopped a lot of work.

Harry has been married to his wife, Wanda, for 51 years. They had two children, one who passed in 2018. They have 5 grandchildren. Their son Andy, (he also lives in EDH), is a Sgt. of Detectives for the Sac PD and he has 3 girls. Their daughter-in-law, Carisa, lives in Livermore and has two boys. Harry and Wanda hit the road frequently to attend soccer matches, cross country and musical /theater events at the Harris Center.

Harry was born in Sacramento, in 1949. His parents lived in Placerville at the time. They moved shortly after Harry's birth to Texas, where he grew up and attended public school in Dallas. He attended Texas A&M, where he was the editor of the "Texas A&M Engineer". He graduated first in his ChE class and was selected as a Distinguished Student. He also graduated with honors. While working for Chevron, he lived in Mississippi, New Jersey and California.

Harry stays active by attending a local gym, playing golf and working on crafts such as woodworking. As mentioned, he is an avid reader and puts out a summary each year of the books that he read in that year. Harry joined SIR Branch 95 in November 2023 and was introduced to us by Terry Privott whom he knows from their church, Vintage Grace.

Does anybody want to review a good book you have recently read? If so, let me know and we can include it in this column in the future.

As you have noticed, I've morphed the book exchange article into a monthly book report so that we can share ideas on good books we have recently read. I got no volunteers for November, but I did get a recommendation from Steve Thomson. So, I looked it up, and here is a review Steve provided, sounds interesting.

Review by Carol Rollins:

"Horse" by Geraldine Brooks

A discarded painting in a junk pile, a skeleton in an attic and the greatest racehorse in American history. From these strands, a Pulitzer Prize winner braids a sweeping story of spirit, obsession and injustice across American history. This story goes between Kentucky in 1840 to New York City in 1954 to Washington, DC in 2019.

It was already getting a lot of attention and the author I learned, is a Pulitzer Prize winner. I'll be honest I had no idea what the book was about. Horse is told from the perspective of multiple people...beginning with Theo, a black man in Washington DC in 2019...who is a PhD candidate and writer for a magazine. He had a particular interest in equestrian art. We also met Jess. Jess is a white woman working for the Smithsonian. She works with articulating skeletons and Horse goes into the meeting of Jess and Theo.

Geraldine Brooks then transports us back in time to 1851 to meet Warfield's Jarrett. Jarrett, born into slavery. He is sensitive and gifted with horses. We learn about the breeding of a violent stallion Boston to an anxious mare Alice Carneal.

The product of this breeding was where this story ultimately begins. From this pairing came a blood bay cold with 4 white feet. He was a horse named Darley...who we will learn eventually becomes Lexington.

Throughout the book, we follow two storylines. This first is the story of Jarrett and his beloved Lexington while the second brings us back into the modern day as we rediscover Lexington's painting and skeleton.

It didn't take me long before I realized this book is more than one about a beloved horse. Horse also begins a conversation comparing the progress (or lack thereof) of racism in the United States from the 1800s to today.
