Costco cookies for luncheon dessert to control our lunch cost for members. We have also tapped into these funds to finance promotional programs when the opportunity arises. Recently, we invested a few hundred dollars in a Four Seasons/Heritage Senior Resource Fair and we expect that our exposure to hundreds of people in our target demographic will add to our membership growth goals in 2025. In the future, we also intend our treasury to be used to support added events and activities.

Our treasury funds situation has also enabled us to keep our membership dues steady at \$40 per year per member, and this is in spite of a modest \$1 increase in State SIR member annual assessment.

Regarding our meeting dates, Cameron Park Country Club (CPCC) has confirmed all of our second Wednesday monthly dates excluding June (our annual picnic date), and the months of September and November where we will have to meet on the 3rd Wednesday of those months due to Country Club member events.

Regarding the cost of our monthly luncheons, we will see an 8.5% price increase, from \$35 to \$38 per person. CPCC offers the following explanation:

The cost of SIRS events for the upcoming year will be raised from \$35 inclusive to \$38 inclusive. This price increase is necessary to cover cost increases specifically involving commodity pricing and increased labor costs.

Please note, we have had to begin implementing a flat facility fee for all new and upcoming events at our club. We worked hard to avoid this additional cost for your group, as you have been consistently meeting at our facility and we want to maintain your business while still being able to provide the experience your group has grown accustomed to. This is the smallest price increase we have implemented to returning groups.

This \$3 per luncheon increase means our members will pay \$30 more per year in total for the 10 luncheons we enjoy there. The fact that we do not pay a facility fee is huge and the fact they will not ask for one in 2025 is really significant. The BEC and I think we can all still regard our pricing for such a nice meeting facility and such good quality food as a very good value. We consistently get feedback from our members about what a great facility CPCC is for our meetings.

Our final event of the year is our annual Holiday Dinner on Wednesday December 11th which includes our spouses and significant others. See Ron Wadsworth's Little SIR article for more details. Ron and his committee have done a very good job planning the event. It promises to be another great Gold Country Branch 95 event. We will eliminate the "business" we have conducted in the past and focus on the fun, gift baskets and relaxation. As I mentioned earlier, we will install our slate of officers at our first business meeting in January instead of at this dinner event.

Finally, an activity update. After a couple years of trying to get a Book Exchange going...hauling books around and writing a lot of book reviews...I have decided to hang it up. We never got much traction on it; so, I don't think it will be missed. I may still write an occasional review of a good book I have read (I'm just finishing the David Baldacci Atlee Pine series). On a brighter note, the Best Burger Pursuit activity I started has really become popular. I want to thank Dan Koelzer for taking this over and heading it up for me while I was Big SIR. The statistics he keeps are amazing! Thanks for that Dan.
