# MEMBER PROFILE | Lew Chapman, PBS 510-912-5658

This article will be an ongoing feature of our SIR Branch 95 newsletter. We would like to include a member profile in the monthly newsletter as well as have a member speak about themselves at our monthly luncheons. In this way, we will get to know about 20 members, over the course of a year, in a more detailed way.



This month's profile is about Ron Wadsworth, our Big SIR for 2025. It seems appropriate, since as our new Big, we should know more about him and how he got here.

For those of you who may have missed it, Ron presided over our November 2024 luncheon as a practice run for January and did a great job. Moreover, he also organized our annual December Holiday Dinner and served as Master of Ceremonies and Auctioneer (with the help of his wife Tami and committee). He did a really great job with that, too. Who knew he was such a comedian and so witty?

Ron was born in December, 1959 in Orange, California, while his father was stationed at El Toro Marine base. He grew up in a family of six, learning the value of resilience and adaptability early on. That is probably the theme of this biography - resilience and adaptability.

His father was a star basketball player at Saint Mary's College before joining the Marine Corp's officer program. As a Marine pilot flying the F-4 Phantom, his father's career led them to move frequently. While his father was stationed at Quantico in Virginia, Ron attended two years of high school in Mt. Vernon, Virginia. By then his father was a Lt. Colonel and was promoted to Commander of the F-4 Squadron back in Southern CA. Ron finished high school in Tustin, CA at Foothill HS. He attended 12 different schools before graduating high school! That's adaptability.

Out of high school, Ron was accepted to the University of California, Santa Barbara (UCSB) but was asked by his dad to stay home to support the family following his mother's passing at a very young 41 years old. He became an "adult" quickly for his younger siblings—a 14-year-old brother and a 9-year-old sister—while his father continued serving as an active-duty Marine. His older sister was just getting her college experience going at UCSB. That did not prevent Ron from pursuing his higher education objectives, so he managed to help his dad with the family, while doing full-time coursework at a local community college AND while working full-time in restaurant management, building valuable leadership and organizational skills. He put himself through college and helped take care of the family. Now, that is some resilience.

Ron had a physically demanding job, working as a logger in Washington during summers. Ron also discovered a passion for running, achieving top 4% finishes in most long-distance races across California, finishing five full marathons as well. More resilience!



After his two years at the JC, he matriculated to Cal State Fullerton and graduated with a business degree. Due a well-deserved break and adventure, he then embarked on a 45-day, 12,000-mile cross-country road trip across 40 states and Canada before starting a career in manufacturing in Los Angeles. While living and working in SoCal, he met his future wife Tami at a church function and started running with her (or is it "after" her?). When he confirmed she could run, he figured he should marry her before she could run away, which he did at age 32, beginning a lifelong partnership filled with shared goals and family values.

During all that, he founded and successfully ran a business with a high school buddy in international export sales in the 1980's. They exported electronics, *etc.* and their biggest selling product was an ultrasonic mice exterminator. There has got to be more to that story!

Ultimately, Ron moved on and took a leadership role at Cardinal Health, a Fortune 15 healthcare supplier. He was Director of Operations at their Elk Grove distribution center. After five years in that role, he was promoted to a VP position in the corporate headquarters in Dublin, Ohio. Having punched that ticket, he got a chance to move back to CA and became a Regional VP working again out of the Elk Grove facility, and that is when he and Tami and growing family decided to reside in El Dorado Hills.

Ron retired almost 3 years ago, in March 2022, after 24 years at Cardinal Health. Shortly thereafter, he was walking the dog(s) in Promontory Park and saw the SIR sandwich board at the bocce ball courts. He picked up the Branch 95 flyer and the next month was out playing with the golf group and ended up joining SIR in June 2022.


