THIS MONTH IN HISTORY | Randy Scott 916-834-9475

1877: At his laboratory in West Orange, New Jersey, Thomas Edison spoke the children's verse "Mary had a Little Lamb..." while demonstrating his newly invented phonograph which utilized a revolving cylinder wrapped in tinfoil to record sounds.

1903: After three years of experimentation, Orville and Wilbur Wright achieved the first powered, controlled airplane flights. They made four flights near Kitty Hawk, North Carolina, the longest lasting about a minute.

1942: Physicists led by Enrico Fermi carried out the world's first successful nuclear chain reaction at the University of Chicago.

1947: The transistor was invented at Bell Laboratories by John Bardeen, Walter Brattain and William Shockley, who shared the Nobel Prize for their invention which sparked a worldwide revolution in electronics.

1982: The first permanent artificial heart was implanted in 61-year-old Barney C. Clark by Dr. William DeVries at the University of Utah Medical Center in Salt Lake City. Clark, who was near death at the time of the operation, survived 112 days after the implantation.



As of this writing, we only have two golf dates left in the 2025 season. By the time you receive this newsletter we will be down to one. The winner of the Gold Country Cup and Marksman of the Year awards will be presented at the luncheon in January.

For those new to SIR 95 golf, if you have not submitted your application and membership fee yet, now is the time. I told some of our members to hold off joining because NCGA would charge for both 2025 and 2026, if we add you to our roster before the first of the year. When you join now, I can submit your information to NCGA the first week in January and you will be on our roster before the 2026 season starts. If you need more information. check out the golf page on our website or contact me. Next year's schedule will be posted in January.

We currently have 44 members on our roster. I have been contacted by 3 members that they will not be renewing for next year and another 22 have already paid next year's dues. Please either let me know you do not wish to renew, or get your \$55 dues payment to me by mid-December. Remember the \$55 includes NCGA membership, which is increasing by \$2 in 2026.

Our 2026 golf season will start on February 3rd at Empire Ranch. The season will end on December 8th at Mather. We have 41 golf dates scheduled for the 2026 season and hopefully we can avoid most rain days, although there are usually one or two rounds dropped either because of rain of very high temperatures.

Also, please be aware that like almost everything else, the rates at most golf courses are increasing this year. Most of the increases are around \$3 or \$4 dollars per golfer. Also, more courses are now requiring one payment be made in place of golfers paying individually. We will discuss this in more detail over the winter months.

Finally, thank you for your participation this season. It is always a pleasure to get to know more of our members through playing a round of golf with them. Thank you also to Dennis Petersen for again agreeing to be Golf Director at Mather and for Randv Hood for agreeing to be Golf Director at Wildhawk. I will continue to be responsible for golf at Empire Ranch and the fourth Tuesday golf tournaments.



region. The day and time will generally be sent out to those on the email list. Call me to get on the list.



 game is not completed, that game will not be used. However, all other full games bowled in the series
 will be used: and
- SBTA will be updated after each tournament and before the next scheduled tournament.
