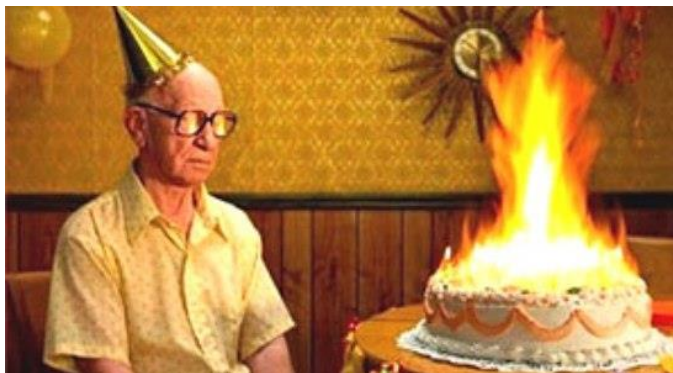
From Little SIR:
